- World War II was neither an accident of history; the work of a psychopath named Hitler; nor of a bunch of Nazi hooligans. It was the deliberately planned and brutally carried out plan of the world’s largest multi-national chemical/pharmaceutical business of the time – Germany’s IG Farben cartel – to conquer the globe in this emerging market.
- These facts are not the result of a recent re-evaluation by historians; nor of speculation; nor of conspiracy. They are the findings of facts established during the War Crimes Tribunal against the IG Farben cartel that was conducted in the Palace of Justice of Nuremberg from August 27, 1947 to July 30, 1948.
- That these important historical facts about who was ultimately responsible for the death of more than 60 million people were hidden away from the people of America and the world was not coincidence or neglect. It was a deliberate act orchestrated by those global economic interest groups, mainly around the Rockefeller group, who had been the principal competitors of IG Farben for global dominance and who – as the victors – had taken the multi-billion dollar package of patents and shares as their booty.
- Thus, the pharmaceutical industry, pretending to be the purveyor of health to millions of people, was the organiser of misery and death in genocidal proportions.

- More than one million Jews and prisoners of war from all over Europe were murdered in the gas chambers of Auschwitz – and even the poisonous gas itself, Zyklon B, was produced by a subsidiary of IG Farben.
- As early as 1940 - at the height of their military success – made detailed plans for a new economic order of Europe and the world. These plans, together with the IG Farben assets, fell into the hands of the economic power circles in the Allied countries – predominately the USA – and became the basis for a “new world order” under new ownership.

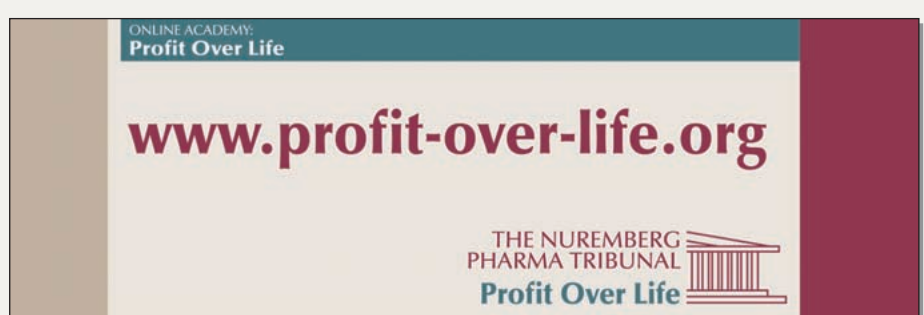

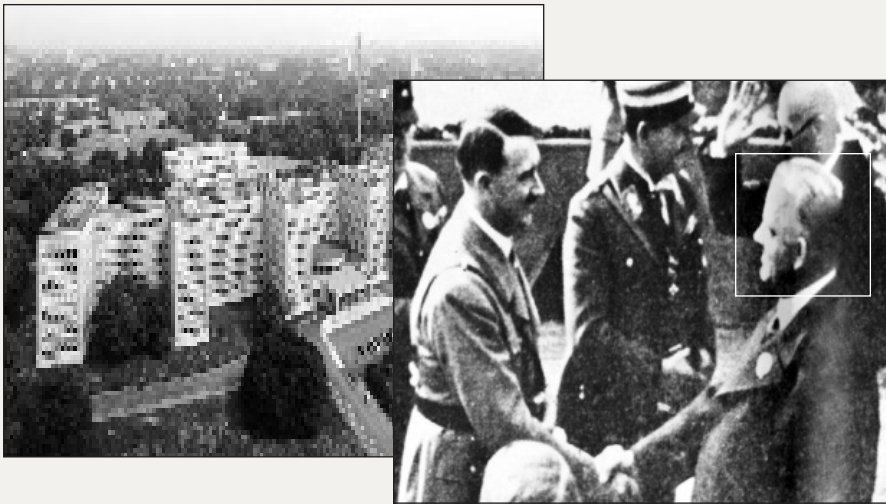
## GLOBAL DECEPTION #4:

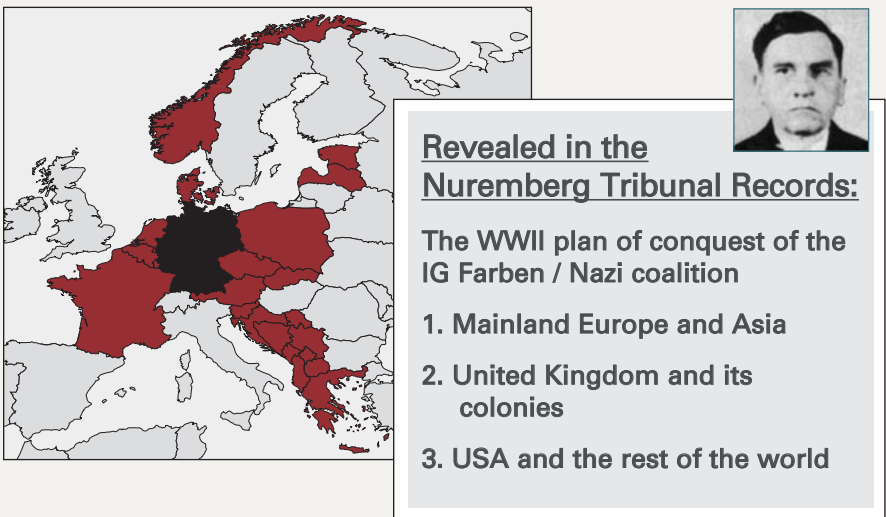


# – Revisited –



## HISTORIC FACT #1:

The Nuremberg Pharma Tribunal of 1947/48 records document that WWII was planned and prepared in this building in Frankfurt, Germany – the headquarters of IG Farben (*far left*). This infamous cartel of Bayer, BASF and Hoechst was the world’s largest chemical/pharmaceutical multi-national at the time. To cement its global monopoly in this field, it financed the rise of the Nazi party and its preparation for the military conquest of Europe and the world. IG Farben’s directors, including CEO Schmitz (*near left*), kept in close contact to their political puppets.



## HISTORIC FACT #2:

The Nuremberg Pharma Tribunal records document that already in 1936 – 3 years before WWII started – IG Farben executives were responsible for preparing the so called “4 year plan” – the master plan for the conquest of Europe. In every country taken over by Hitler’s army (*far left*), IG Farben received the entire chemical and petrochemical industries at zero cost. The plan of the IG Farben/Nazi coalition had three stages: first, mainland Europe; second, the UK and its colonies; third, the US and the rest of the world.



## HISTORIC FACT #3:

The Nuremberg Pharma Tribunal documents that it was IG Farben that built the Auschwitz concentration camp into a giant forced labor and extermination site. Hundreds of thousands of slave laborers were forced to construct “IG Auschwitz” – the largest industrial plant in Europe at that time and a four-mile march away from the concentration camp. The camp and the plant cost IG Farben nearly one billion Reichsmark (about \$10 billion in today’s currency) and was financed by Deutsche Bank.

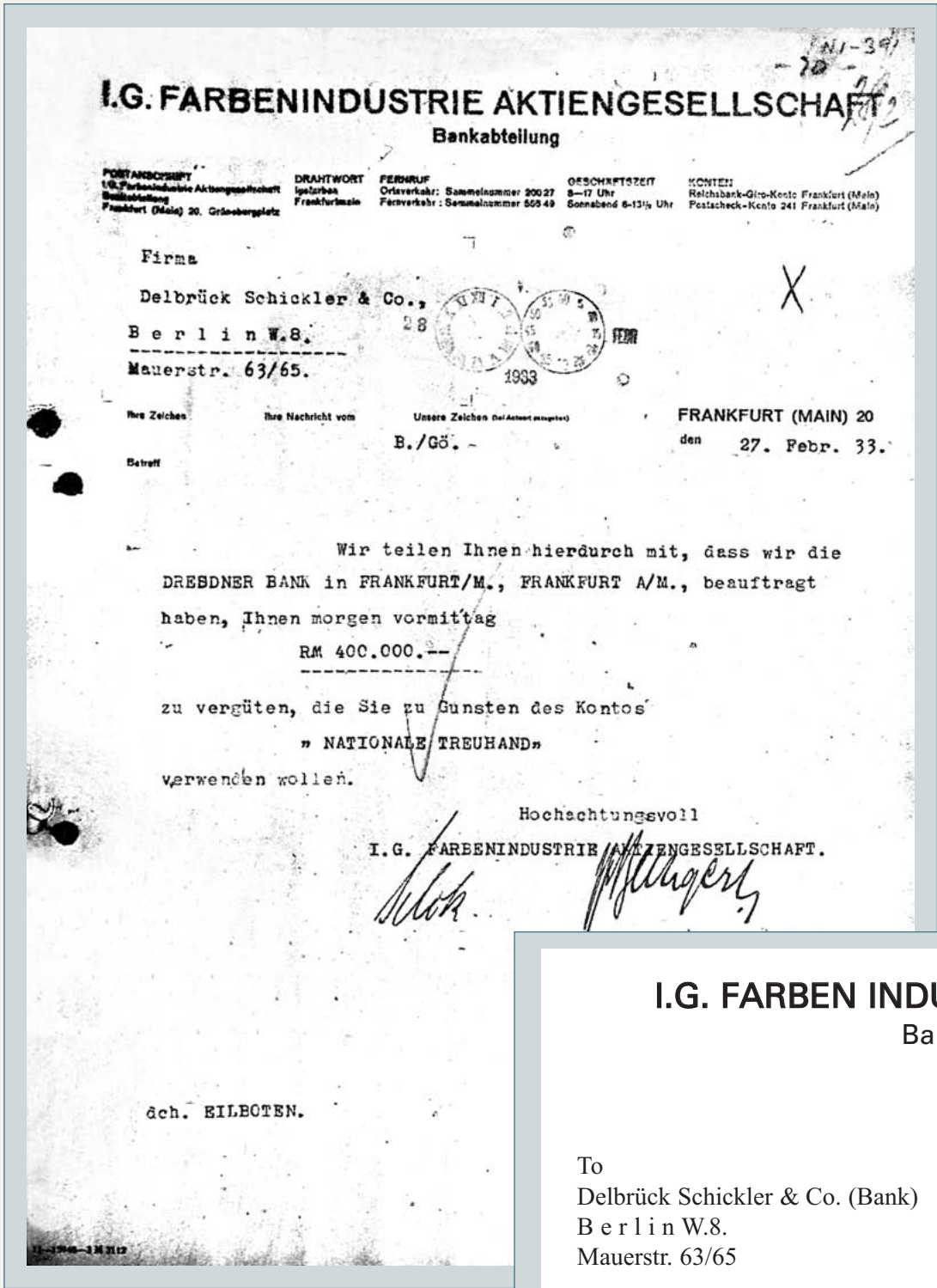


## HISTORIC FACT #4:

The Nuremberg Pharma Tribunal records clearly show that the deadly medical experiments conducted in Auschwitz and other concentration camps were contracted by Bayer’s and Hoechst’s pharmaceutical divisions. The “drugs” injected into tens of thousands of innocent inmates were previously untested chemicals (*far left*) patented by Bayer and other IG Farben firms. Most of the victims died during these cruel experiments. Those who survived were frequently sent to the gas chambers. Even the pellets for the gassing – Zyklon B (*near left*) – were provided by subsidiaries of IG Farben.



# Just One Of Tens Of Thousands



This page documents just one of tens of thousands of documents from the Nuremberg Pharma Tribunal. It is the copy of an authentic letter sent by the bank division of IG Farben to the Bankhouse Delbrueck in Berlin, instructing them to transfer the amount of 400, 000 Reichsmark to the “National Trust Fund”.

This “Trust Fund” was an official account for the Nazi party. The amount of 400,000 Reichsmark translates into tens of millions of dollars in today’s currency.

The letter was co-signed by Hermann Schmitz, the CEO of IG Farben, indicating that the decision to massively support the Nazi party was taken at the highest level of this chemical / pharmaceutical multinational.

This and thousands of other documents, letters and other records, unequivocally documents the close connection between the IG Farben corporation and the Nazi party.

When you browse through this online archive of the Nuremberg Pharma Tribunal, and turn page after page, you will notice how the curtain of deception is being pulled away.

Once one understands the devastating influence of multinational corporations on political leaders – then and now – the actions of these leaders are no longer a mystery.

Nowhere in this book will you read a direct comparison between Hitler and a political leader of today. In many respects, the events of today cannot be compared to the events more than six decades ago.

# Of Breathtaking Documents



On February 27, 1933, the Nazis set the German parliament building (Reichstag) in Berlin on fire, which was completely destroyed (picture at left).

February 27, 1933, was precisely the date when the check from the IG Farben headquarters had arrived at the Nazi bank accounts (see letter on opposing page).

In other words: on the very day the largest German corporation, IG Farben, made its first strategic financial investment in the Nazi party, these unscrupulous elements organized a political coup to seize dictatorial powers.

And here was their master plan: the Reichstags fire was immediately blamed by the Nazis on their political opponents. The German mass media – already staunch supporters of the Nazis – supported this witch hunt.

The Enabling Acts granting dictatorial powers to the Nazi government were already prepared and ready to be enacted. On March 24, 1933, the Nazis passed the first of these major laws that would turn German democracy into a dictatorship.

This law was entitled “Homeland Security Act”.

Article 5 of this law contained the provision that this dictatorial law would expire four years later, on April 1, 1937. Of course, the Nazis never had any intention to let their dictatorial powers expire at any time.

The Nazis knew that with the acceptance of the huge IG Farben payment, their order was clear: prepare for war and for the military conquest of the oil fields and the chemical factories of the world.

### Law for the Protection of People and Homeland (Homeland Security Act)

#### Summary

#### Article 1

Laws can be enacted directly by the government, without approval by parliament.

#### Article 2

Laws enacted by the government do not need to comply with the constitution.

#### Article 3

The laws enacted by the government are executed by the chancellor [Hitler] and published in the Law Gazette.

#### Article 4

Treaty of the German Reich with foreign states do not need the approval of parliament.

#### Article 5

This law is effective on the day of its publication. It will expire on April 1, 1937.

# From WWII

## 1933 - 1945

These two pages summarize a century in human history in which the oil and drug cartel abused our planet as the playing field for its military adventures with devastating consequences for its inhabitants.

The German drug and oil cartel IG Farben strategically directed its investments into bringing the Nazi party to power, changing German democracy into a dictatorship and providing scientific, economic and logistical advice for the military conquest of Europe and the world – WWII.

After the IG Farben/Nazi coalition had lost WWII the victors decided on three measures:

- Many leading political and military stakeholders of IG Farben during WWII were sentenced to death.
- The corporate executives of IG Farben – after a short interlude in prison – were reinstated into their previous positions as “tribunes” for the new masters.
- The shares of IG Farben, of course, went to the investment groups behind the main competitors of IG Farben, namely Rockefeller’s Standard Oil trust.

Today, the oil and drug cartel is largely governed by the financial interests around the Rockefeller group. Not surprisingly, all of the US Presidents since WWII were members of the “Council on Foreign Relations” – a sort of “political brotherhood” founded by the Rockefeller brothers.

The strategic investments of this group have not changed. Along with other industries, they essentially control the global pharmaceutical investment business, with an estimated global worth of tens of trillions (!) of dollars.

Now that the pharmaceutical investment business has been globally exposed as a giant organized fraud - promising health but thriving on diseases - the credibility of this industry is gone and its entire existence is at stake. The only condition under which this multi-trillion dollar fraud business could be continued is under a global state of dictatorial or martial laws and this – in turn – can only be the result of global war.

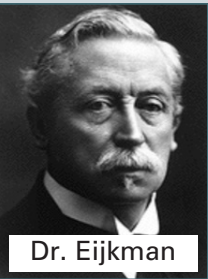

There must have been a reason why the genocide committed on behalf of the pharmaceutical industry in Auschwitz was hidden away from us for decades. That reason – of course – is that these very same interest groups were determined to organize an even bigger threat to human health, this time on a global scale.

Most of IG Farben's deadly experiments in Auschwitz were done with a new category of patented chemicals, deceptively called "chemo-therapy." Substances deriving from these chemicals were – over the following decades – injected into millions of cancer patients with the false promise of a chemo-"therapy" or even a cure.

For decades no one told those patients the the origin of these extremely toxic drugs were the chemical agents – like mustard gas – that were used in chemical warfare during WWI and killed millions of soldiers. The key patents for both applications – chemical weapons and chemical drugs – were held by "Bayer" and other IG Farben companies.

Thus, it is an historical fact that the cradle for the global market of ineffective and highly toxic chemotherapy for cancer – and more recently for AIDS – lies in Auschwitz and other concentration camps.

It is unacceptable that the oil and drug cartel has not only suppressed the information about its criminal past for decades. For the same period of time, it has also suppressed the fact that effective therapies were available for preventing and controlling most chronic diseases, including cardiovascular disease and cancer. However, these remedies had an important disadvantage – they were not patentable. These effective, safe and affordable preventive and therapeutic agents are called vitamins.

Already at the time when the pharmaceutical executives were sentenced for genocide and other crimes against humanity in Nuremberg, more than half a dozen Nobel Prizes had been awarded for the life-saving role of vitamins in the fight against many diseases (see box). In other words, the world had bowed down in front of scientists who, with their research into vitamins, had made contributions that benefit all mankind.

Imagine how many billion dollars it must have cost the spin masters of the drug cartel to suppress that information too!

## Laws of the Pharmaceutical Investment Business With Disease

- 1** The pharmaceutical industry is not a health business but an investment industry.
- 2** The patentability of drugs and the height of the patent royalty fees determine the return on investment of this industry and are the driving force behind it.
- 3** The prevention and eradication of diseases destroy the markets of this investment business and therefore, the business strategy of this investment industry is the expansion of diseases.

**4** These business principles also determine the natural "enemies" for the pharmaceutical investment business: any health approach that prevents or cures diseases and that is not patentable.

**5** Vitamins and other science-based natural health approaches fulfil both these criteria. Their worldwide acceptance in medicine inevitably terminates the pharmaceutical investment business.

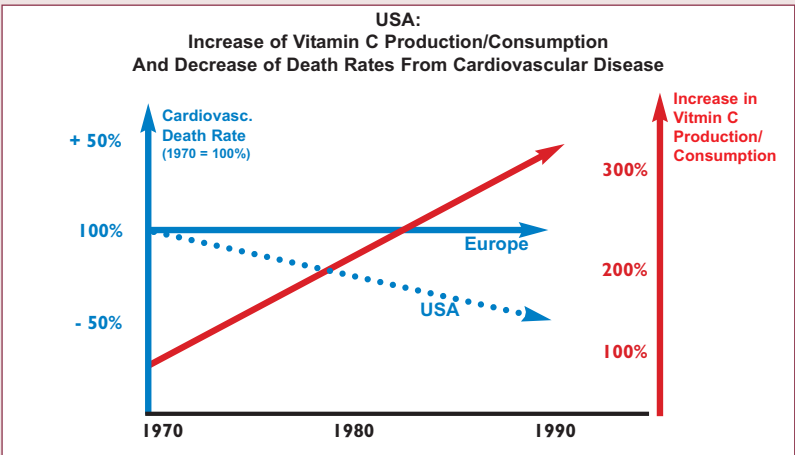
# Genocide Now!

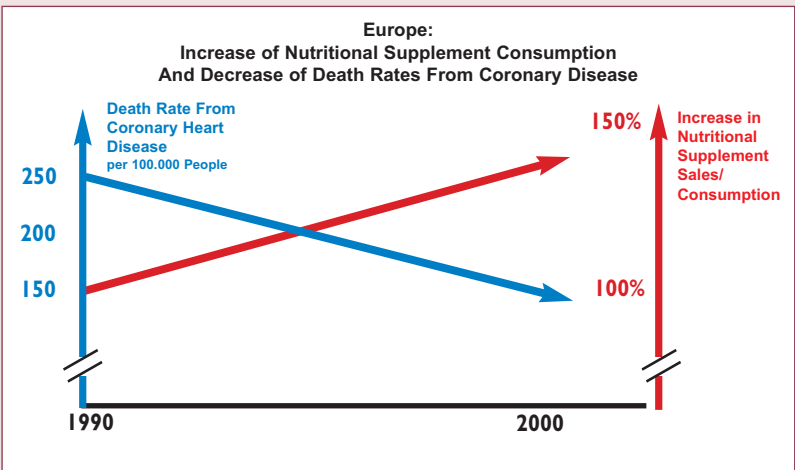

It is high time to present the global epidemiological evidence that has become available over recent decades despite the fierce resistance of the pharmaceutical cartel:



In 1970 Dr. Linus Pauling published his first book on "Vitamin C and the Common Cold" which became an immediate bestseller in the US. Vitamin C sales/consumption figures more than tripled over the next decades and cardiovascular disease in the US dropped by over 50%. In Europe – fenced off by the drug cartel from this life-saving information – death rates from cardiovascular disease continued to remain high.

With the discoveries by Dr. Rath about vitamin deficiency as the primary cause of cardiovascular disease in 1990 and the translation of his book into all major European languages, the people of Europe could also benefit from this breakthrough in natural health:



Between 1990 and 2004 vitamin consumption in Europe rose on average about 30%. Now here too, the death rate from coronary heart disease in France, Germany, UK and other European countries dropped an average of 30%.

The details of this breakthrough in the natural control of cardiovascular disease – including its natural reversal – are documented in the Appendix of this book.

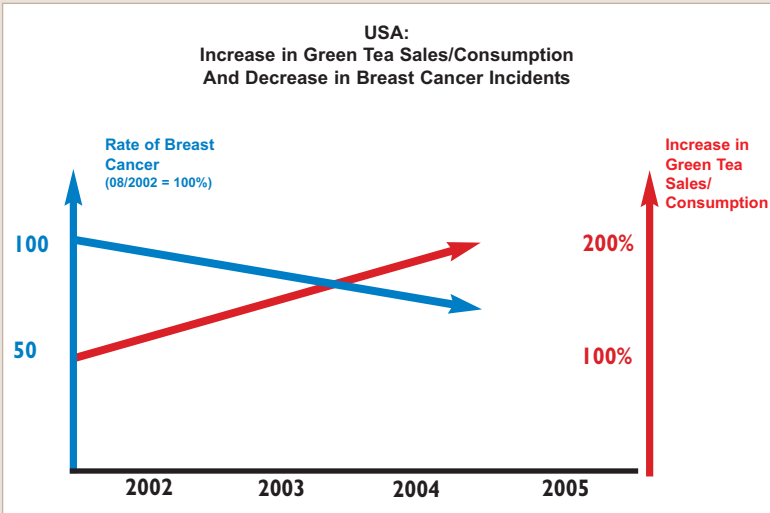
## Suppression of Life-Saving Information For the Control of Cancer

Until today cancer is being promoted by the pharmaceutical industry as a death verdict and this deliberate scare tactic has forced hundreds of millions of desperate cancer patients over recent decades into the arms of the drug cartel. For this cartel the cancer epidemic was a multi-billion dollar market that needed to be continued and expanded. Not surprisingly, the answer of the pharmaceutical business to these desperate cancer patients was drugs ("chemotherapy") the most frequent side effect of which was – new cancer.

In March 2002 Dr. Rath and his research team published their discoveries about the natural control of cancer in "USA Today", the world's largest newspaper. The key information was that vitamin C in combination with other micronutrients and extracts from green tea can block cancer cells from spreading.

Over the next two years, following this publication, the sales of green tea more than doubled. And on December 15, 2006 the "New York Times" reported in a title story that, for the first time in decades, breast cancer in the US had dropped a staggering 15%. The explanation provided in the article, unfortunately, made no mention of this important connection.

With the publication of these breakthroughs in natural health – in combination with the epidemiological confirmation from around the world – the "wall of ignorance" built by the drug cartel will be tumbling down like the "Berlin Wall."
