Stop Bush! Stop WWII!

The world is closer to WWII than ever. Until today no one has provided a convincing answer as to "why?" The purpose of this Open Letter is:

1. To expose the agenda behind the Bush Administration's plan to launch WWII.
2. To Prevent the execution of this plan through this public exposure.

The Bush Administration's Goal: Launching World War III

Why Does the Bush Administration Seek to Launch World War III?

Parallel to the global military escalation, the Bush Administration has domestically made every preparation to turn U.S. democracy into a dictatorship. Again under the pretext of fighting terrorism a series of empowerment laws have been passed, including the Patriot Act, the Homeland Security Act, the Biodefense Act and others.

The common denominators of these acts are:

1. The abolition of most U.S. civil rights.
2. The granting of direct access to executive and legislative power for the pharmaceutical and petro-chemical industries - the drug and oil cartels.

The only step needed to activate this entire set of empowerment legislation is a world war with the ensuing martial laws.

Protecting the Multi-Trillion Dollar Drug Investment Business

The outrageous step of preparing WWII cannot be explained by the desire to gain access to oil fields. Only the foreseeable economic loss of catastrophic proportion can trigger such a desperate action. This is the imminent collapse of one of the largest investment industries: the multi-trillion dollar pharmaceutical drug business with disease.

The scandals from the deadly side-effects of Vioxx, Baycol and other widely used drugs are already threatening the economic basis of the largest drug makers in the world. Now the survival of the entire pharmaceutical industry is at stake. Constructed as an investment business based on patented drugs, this industry has been unmasked as a giant organized fraud: it promotes "health" but its entire existence depends on the continuation and expansion of diseases as multi-billion dollar drug markets.

To protect its business with patentable drugs from competition by effective, non-patentable therapies, the stakeholders of the pharmaceutical business have consistently excluded research with non-patentable natural substances. Moreover, they have strategically barred basic knowledge of biological science in this field from entering the medical practice to fight global diseases including heart disease,

cancer and immune deficiencies. If this basic knowledge had been implemented into medicine when it became available decades ago, neither the scope of most diseases nor the size of the drug investment business would have reached today's magnitude.

Now that the deceptive strategy of this "business with disease" has been unmasked, its entire credibility is at stake and with it the survival of multi-trillion dollar markets of patented drugs. The desperate effort to prevent the largest financial collapse in history is the driving force behind the plans for WWII.

Now World War III Is No Longer Possible!

The next months will see the Bush Administration threatening military action and wars against Iran, North Korea and other countries. However, with the publication of this information the launch of WWII will no longer be possible because:

1. The agenda behind these war plans has now been revealed.
2. The governments of the world can no longer be coerced by the Bush Administration into such wars – regardless of the pretext.
3. The governments of the world can now establish a new world parliament. As a precondition to lasting world peace, this global

Bush's and Rumsfeld's Plans To Launch World War III Evaporated *Background of the World War III Agenda of Bush Administration Exposed*

The past week saw hardliners of the Bush administration launch an unprecedented attack on its critics. Leading this assault was Secretary of Defense Donald Rumsfeld in a speech before the American Legion on August 29, 2006. All major news organizations - including the Los Angeles Times, the New York Times, the Washington Post, USA Today and CNN - interpreted Secretary Rumsfeld's rage as targeting administration critics.



But when Pentagon spokesman Eric Ruff was asked about these statements he denied that Rumsfeld had attacked any war critics. Mr. Rumsfeld allegedly addressed a "broad array of people and organizations." In a remarkable move, the otherwise trigger-happy Pentagon declined to name any of them.

Throughout the administration's tenure Rumsfeld has been seen as the Teflon-like communicator with an unwavering stand as the architect of three major wars and even facing growing demands for his resignation. So what was the triggering event that made this man lose his temper in such an extraordinary way?

Since the Pentagon and the Bush administration are apparently unwilling to reveal what triggered this rage, we have published the answer in the September 7, 2006 edition of The New York Times. In this most recent open letter, Dr. Rath explained that Rumsfeld's attacks were directed at The New York Times for publishing the message that unmasked the Bush administration's plan to launch WWII.

Donald Rumsfeld's attacks were a direct reaction to the following facts:

1. Dr. Rath's open letter revealed the hidden WWII agenda of the Bush administration;
2. The New York Times was courageous enough to publish this plan; and
3. The combination of these two facts makes it impossible for these plans to be executed.

The text of Dr. Rath's August 25, 2006 open letter in The New York Times (see above) ties together the many seemingly separate events that have set the stage for a third World War. Among these are the destruction and occupation of Iraq without cause, the newly established presidential directive allowing the use of nuclear weapons in a preemptive strike, the escalation of violence in the recent conflict between Israel and Lebanon,



and the passage of draconian legislation that threatens individual freedom and privacy domestically.

The preparation for a war that inevitably would include the weapons of mass destruction and result in the death of millions of people is an accusation not easily made against anyone. Moreover, such an outrageous step of preparing for WWII cannot be explained simply by the desire to gain access to oilfields. "Only the foreseeable economic loss of catastrophic proportion can trigger such a drastic action: this is the imminent collapse of

one of the largest investment industries, the multi-trillion pharmaceutical business with disease," says Dr. Rath.

Two factors characterize the imminent meltdown of the pharmaceutical industry. First, as an ever-increasing number of FDA approved drugs exhibit deadly side effects, drug companies are finding themselves exposed to multi-million dollar lawsuits from thousands of injured patients.

Second, in his open letter, Dr. Rath points out an even greater threat for the drug business: "Constructed as an investment business based on patented drugs, this industry has been unmasked as a giant organized fraud: it promises 'health' but its entire existence depends on the continuation and expansion of diseases as multi-billion dollar drug markets."

In order to protect their investments in the global market with patentable drugs, the pharmaceutical stakeholders have systematically suppressed even the most basic knowledge about natural, non-patentable health documented in every textbook of biology for almost a century and have obstructed its application to medicine in favour of their patented chemical drugs.

As a direct result of this decade-long suppression of life-saving health information in favour of constructing the multi-trillion dollar investment business with disease, tens of millions of people have died unnecessarily from diseases that could be eradicated by now - including heart disease, cancer and other widespread health conditions.



The pharmaceutical investment business has now been revealed as the largest fraud in history, promising health but, in fact, promoting diseases as the very basis for its ongoing business with patented drugs. The continuation of such an unscrupulous business conducted at the expense of the health of millions of citizens is only possible if democracy is replaced by a totalitarian form of government with direct access to executive power by the pharmaceutical industry.

This is precisely the common denominator of the Patriot Act, Homeland Security Legislation and the Biodefense Act – all brought into effect by the Bush administration under the pretext of fighting terrorism.

The only way to make the American people 'voluntarily' concede their democratic rights in favour of a dictatorial rule is to create a psychological state of fear far surpassing that of 9/11. The only conceivable event of such magnitude is a world war that includes the use of weapons of mass destruction.

Dr. Rath is fully aware that the accusation of initiating a war with weapons of mass destruction risking the death of millions of people is a severe allegation. However, considering the magnitude of the crimes committed by the pharmaceutical business with disease, the fear of its perpetrators being held accountable for these crimes is a strong motive to initiate the unthinkable.

Now it is clear why the pharmaceutical industry was the single largest donor of George Bush's election campaign and essentially carried him into the White House. Moreover, we now also comprehend why Donald Rumsfeld, the highest decorated pharmaceutical executive in U.S. history, was appointed Secretary of Defense giving these interests direct access to authorities which can launch global wars.

Thus, it is not surprising that it was Secretary Rumsfeld who first picked up on the devastating revelation of the Bush administration's WWII plan by Dr. Rath in The New York Times. Moreover, his rage towards the media

was nothing more than an attack against The New York Times for having made the decision to publish the Bush administration's WWII plans.

It does not take a degree in psychology or political science that Rumsfeld's erratic reaction confirms that Dr. Rath's analysis published in The New York Times on August 25, 2006 was accurate. Moreover, with the WWII agenda of the Bush administration now being public knowledge, their time is running out. Over the next few weeks, the entire world will see an international military escalation of an unprecedented scope. Never before in the history of mankind have we been closer to a nuclear war than we are right now.

In this dramatic situation Dr. Rath raised his voice again in the New York Times edition of today, September 07, 2006 (see above). It confronts the Bush administration with the undisputable fact, that – after essentially confirming their WWII plans through last weeks rage campaign – these plans can no longer be executed.

The people of America now have the responsibility to peacefully remove those politicians, who continue to endanger world peace. The people of the world now have the opportunity to




Scientific Basis for the Natural Control of Influenza

All Steps of Influenza Infection Can Be Blocked by Micronutrients:


1. Influenza virus gets inside the body cells with the help of the enzyme neuraminidase (N), which is located on the surface of the virus.
2. Within the infected cell, the virus 'reprograms' the genetic software in the cell core to allow its own multiplication. The infected cell now continuously produces more viruses as well as the biological scissors (collagenases) for their spread.
3. Millions of viruses are released from infected cells. With the help of collagen-destroying enzymes, the viruses expand through the connective tissue and invade other cells. The influenza infection has turned into a disease.



1 The activity of neuraminidase, the enzyme responsible for viral infectivity can be lowered by 70% in the presence of micronutrients.



2 Multiplication of influenza viruses in infected cells can completely stop in the presence of micronutrients.



3 Micronutrients decrease the production of enzymes necessary for the destruction of connective tissue and for viral spread in the body.

A potential bird flu pandemic poses a global threat. Since there is no vaccine available, there is an urgent need for effective, safe and affordable treatment of a bird flu pandemic.

The need for low-cost approaches to this health threat is particularly critical for developing regions such as Africa, Asia and South America.

Currently promoted pharmaceutical options are no answer to a global pandemic either. According to the manufacturer of *Tamiflu*, this drug can reduce the symptoms of influenza by merely one day.

Thus, while the benefits of this drug are limited, its cost of about \$10 per pill is prohibitive as a public health measure for the great majority of nations.

Micronutrients As Effective Safe and Affordable Alternatives to the Bird Flu Threat

With neuraminidase inhibitors and other pharmaceutical drugs offering limited options to fight a global pandemic, there was an

objective need for preventive and therapeutic options that allow the great majority of nations to prepare for such a global pandemic with effective and affordable public health strategies.

The most promising approach to immediately reach this goal is the use of micronutrients (vitamins, minerals, plant polyphenols). Their effectiveness to improve the immune function is already part of every textbook of biology. At our research institute, we tested a micronutrient composition for their effectiveness, specifically in blocking influenza infection.



The Background

Having burst the AIDS bubble in 2005 with the publication of the landmark results of our community health program in South Africa, the pharma-drug cartel needed another screen behind which to hide their true intentions. What better than a public health crisis?



Languishing in the background was the so-called “deadly” bird flu epidemic. By heavily publicizing the news that there was not enough vaccine to treat the disease – a lie in itself: based on the evidence of the manufacturer of Tamiflu, this drug can reduce the symptoms of influenza by merely one day – bird flu could be re-launched as a pandemic health threat guaranteed to send the people of the world into shock.



Alive to these machinations, we published our research findings as public health information on March 23, 2006, to illustrate how nutrients can affect all important stages involved in influenza infection.

The Reaction

In her opening remarks before the Senate Appropriations Subcommittee on State, Foreign Operations, and Related Programs on March 28, 2006, Condoleezza Rice tried to talk up both the AIDS crisis and the bird flu pandemic in order to justify her budget request for the Department of State.

During her statement she openly referred to opponents of drug markets as the declared enemies of the White House.

Not for the first time, we had them worried!


The Background
