

# The Chemnitz Program

In this historic speech, given on Saturday, June 21<sup>st</sup>, 1997, in the City Hall, Chemnitz, Germany Dr. Rath exposed for the first time the pharmaceutical industry itself as the largest obstacle to human health

Today we have come together to make a major stride towards this aim. Today will be the day when we, the people of Chemnitz, Germany, and the world begin to liberate ourselves from the yoke of those who make billions of dollars at the expense of our health. We are determined to protect our health and lives and to liberate ourselves from the perils of cardiovascular death and other diseases.

Throughout thousands of years of recorded history, our ancestors have looked at the night sky and asked themselves about the nature of the universe and the laws that determine movement of the sun, the moon, and the stars. For thousands of years their conclusion was that the earth is the center of the universe, the sun circles around the earth, and the stars are attached to crystal shells in heaven. The daily sunrise in the East and the sunset in the West left no doubt that



these were the laws governing the universe as described by the Greek astronomer Ptolemy.

## Suddenly Everything Changed

It changed with the life of Galileo Galilei. When Galileo was born in 1654, the sun circled around the earth. After he had died, it was the other way around – the earth circled around the sun. Of course, the planets did not change their course during his lifetime. What had changed was the way mankind learned to look at the universe. The scientific discoveries of Galileo Galilei terminated the medieval age in science and inaugurated what we know today as modern time.

Was this groundbreaking discovery immediately welcomed? Of course not. Galileo faced life-long opposition by his colleagues, and the Roman Church banished him for heresy. Now, not even 400 years later, the American spacecraft Voyager has crossed our entire solar system. Everything Galileo discovered has been confirmed. Before Voyager left our solar system into the darkness of the universe, it

turned around one last time and provided us with a fascinating view of our solar system and of Planet Earth. For the first time, a picture was taken that provided us with a unique look at ourselves and mankind's role in the universe. Planet Earth is only a small dot.

New perceptions are not confined to the universe. Of particular importance are these changes in medicine, because they directly affect millions of lives.

## The Greatest Challenge for Health and Life

Throughout history, many other epidemics including plague, cholera, and smallpox, were the number one killers. As recently as 400 years ago, one-third of the European population fell victim to epidemics. The cause of these epidemics was well known at the time: epidemics were the curse of heaven for the sins of mankind.

Everything changed 100 years ago. The French chemist Louis Pasteur discovered that infections are not a curse, but are caused by bacteria and other microorganisms. Pasteur's discovery paved the way for the development of vaccines and antibiotics. Was this important discovery immediately welcomed?

No, of course not. His colleagues and the medical academy attacked Pasteur on the grounds that he was not a physician, but merely a chemist. When cowpox vaccines were first used to prevent deadly smallpox infections, this treatment was openly ridiculed. Nineteenth century caricatures show cows growing out of the bodies of people who had just been vaccinated with the lifesaving cowpox vaccine.

The philosopher Arthur Schopenhauer said: "New thoughts and new truths go through three stages. First, they are ridiculed. Next, they are violently opposed. Then, finally, they are accepted as being self-evident."

## The People Themselves are the Driving Force


It is important that we understand the following: the driving forces behind the acceptance of Pasteur's discoveries were not his academic colleagues. People like YOU discovered that these vaccines could save their own lives and the lives of their children. They did not care about dogmas. People like you swept away the medieval times in medicine. Only 100 years later, the World Health Organization officially declared smallpox as eradicated for mankind.

During the 20th century, heart attacks, strokes, and other forms of cardiovascular disease replaced infectious diseases as the leading cause of death. In

all industrialized countries, cardiovascular disease has reached epidemic proportions. Today, every second woman and man dies from this epidemic, and it continues to spread on a worldwide scale. This is even more surprising considering the fact that the largest study ever conducted on Planet Earth leaves no doubt: heart attacks and strokes are not actual diseases. They are, rather, the direct consequence of long term vitamin deficiency, and they are preventable. Nature itself conducted the largest study ever, with countless study participants and over thousands of generations. One study group in this investigation comprised the entire animal kingdom, 99.9% of all living beings on Planet Earth. Animals don't get heart attacks

because they produce a large amount of vitamin C in their own bodies, which stabilizes the artery walls. The second group in this giant investigation comprises six thousand million people today. Among humans, heart attacks and strokes are rampant because our body cannot produce its own vitamin C and almost none of us receive enough vitamins through our diet.

The most astonishing fact about this study is that hardly anybody knows about it. Don't you think it is high time that we spread the result of this global study everywhere? Don't you think these discoveries are much more relevant to everyone than those made 400 years ago, saying that the earth circles the sun?



## Cardiovascular Disease is an Early Form of Scurvy

This is also the reason that my new book is entitled "Why Animals Don't Get Heart Attacks - But People Do." The answer to this question literally concerns every human being in your town. I urge you to help spread this lifesaving information.

In the book "Why animals don't get heart attacks" is a summary showing how cardiovascular disease is an early

form of scurvy. The left column shows how the artery walls of animals are stabilized by an optimum production of elastin and collagen molecules. The more vitamin C there is the more stable and resistant the artery walls are. The right column shows the other extreme: the sailor's disease, scurvy. During long sea journeys sailors of earlier centuries died within a few months from massive internal and external bleeding. Their bodies did not produce vitamin C, and diet contained hardly any vitamins.

The cause of cardiovascular disease lies right in the middle. We all get a small amount of vitamins in our daily diet, so that open scurvy is rare. However, the vitamin intake from our diet is not sufficient to stabilize the artery walls as in the case with the vitamin C producing animals. Over decades, millions of small cracks and lesions develop at the inner surface of the artery walls. When the surface of the artery walls has become brittle, cholesterol and other repair factors, particularly the sticky lipoprotein-a, enter the artery walls.

The deposition of cholesterol inside the artery wall is therefore not the cause of cardiovascular disease, but a reaction to the underlying problem: vitamin deficiency of the artery wall. With insufficient vitamin supply over many years, the repair of the wall continues and leads to the feared atherosclerotic deposit. If these deposits form inside the coronary arteries of the heart, they lead to heart attack. If these deposits develop in the arteries of the brain, they lead to stroke.

Albert Einstein said: "Truly important discoveries are generally so simple that they can be understood by everyone."

The connection between scurvy, vitamin C deficiency and cardiovascular disease is no exception. We were able to show our patients that it is not only possible to prevent the further growth of atherosclerotic deposits; we also showed that cardiovascular disease can be reversed without bypass surgery and angioplasty. For this therapy, the amino acids lysine and proline play a particular role. They form a Teflon layer for the artery walls and release the fat particles that are already attached inside the artery walls. Existing deposits are dissolved naturally.


## Atherosclerosis at Age 30

Besides fat particles, advanced atherosclerotic deposits also contain calcium molecules. These calcium molecules are so characteristic that they gave the disease athero-"sclerosis" its name. These calcium molecules can also be released in a natural way, as documented in our clinical study. The most important vitamin that optimizes calcium metabolism is vitamin D. Make sure that your daily diet contains an optimum amount of vitamin D.

At age 30, every second young person has already developed early atherosclerosis in their coronary arteries. This disease develops over many years without our knowing it, and if nothing is done, this process will sooner or later lead to a heart attack. Our goal was to develop a natural therapy to stop this dangerous process in its early stages. We knew that if we were successful in halting atherosclerosis, we would ultimately prevent the occurrence of heart attacks, and the eradication of heart disease would become reality. The natural health program that we developed is composed

of vitamins, amino acids, minerals and trace elements, and it has become the world's leading cardiovascular health program. The following clinical study took us a further step on this way. We tested our vitamin program in a clinical study with 55 patients with different grades of coronary heart disease. To measure the degree of coronary artery deposits we used the most advanced diagnostic technology in the world, Ultrafast Computed Tomography, the so-called mammogram of the heart.

The computer automatically measured the size of the deposits within the arteries by multiplying the area and the density of the deposits. From these data the coronary sclerosis factor was obtained. The larger this sclerosis factor was, the more advanced the coronary artery disease. Because of its significance for the health of every human being, I have documented this study in my new book, *Why Animals Don't Get Heart Attacks*. The most important study results are the following: First, we evaluated how fast the atherosclerotic deposits develop in coronary heart disease patients without any vitamin therapy. Every year the coronary deposits increase by 44%



on average. Thus, without any vitamin therapy, the deposits increased at an accelerated speed, every year they increased by half of their previous size. Untreated coronary atherosclerosis does not develop gradually towards a heart attack, but at an accelerated speed. This is the first time that the actual growth rate of coronary sclerosis has been measured.

## Natural Reversal of Atherosclerosis

Subsequently, the patients started with our vitamin program. Under this therapy the development was reversed, and the growth rate of coronary deposits substantially decreased. For patients with early coronary heart disease the process could be stopped within one year.

In individual cases this vitamin therapy led to the complete disappearance of coronary artery deposits in a natural way. The existing deposits have totally disappeared after one year of our vitamin program.


The explanation for this picture is logical: the ingredients of the vitamin program have stimulated a natural healing process of the artery wall.

This study marks a turning point in medicine and in health awareness on a worldwide scale. It confirms that heart attack is the direct consequence of vitamin deficiency. Coronary atherosclerosis, the cause of heart attacks, can be stopped in its early stages.

This study also confirms that the natural reversal of coronary sclerosis is possible and that, in the future, bypass surgery and angioplasty will be the exception. We now also know that the worldwide cardiovascular epidemic can be controlled at a fraction of the previous cost. However, the most important fact is that this medical breakthrough can be used immediately by millions of people worldwide. The application of these findings will lead to a significant reduction of heart attacks and strokes and, to their eradication.

This study also confirms that the following statistic is not a coincidence: vitamin C consumption in the U.S. has increased manifold over the last three decades. In parallel to this the frequency of heart attacks and strokes as the cause of death has been cut in half. Our study now paves the way for similar successes in Europe and other parts of the world. How urgently this development is needed can be seen from the following statistics:

While heart attacks and strokes have decreased by 50% in the U.S., people continue to die like flies from this epidemic in Europe and other parts of the world. In Western Europe, the frequency of heart attacks has remained high constantly, while the frequency of heart attacks and strokes in eastern European countries still increases. Our study also provides an explanation for this phenomenon: every second person in America takes vitamins on a regular basis. In Europe fewer than 5% do.



## Victory Over Heart Attack

Once again, mankind is urged to liberate itself from another disease that has taken the lives of millions of people and brought on indescribable misery over this planet. The only obstacle that we still have to overcome is the resistance by the pharmaceutical corporations. With the continuation of cardiovascular disease, the pharmaceutical industry is making billions of dollars every year. With the eradication of cardiovascular disease, this billion-dollar market is going to collapse.

To assure the continuation of this billion dollar pharmaceutical market, the German and international pharmaceutical corporations have formed a worldwide cartel. They gave this cartel the Latin code name "Codex Alimentarius." The purpose of this Codex Cartel is to bring about international legislation to ban the distribution of lifesaving health information in relation to vitamins.

We have to recognize that the pharmaceutical cartel is deliberately continuing the cardiovascular epidemic in the interests of securing a worldwide pharmaceutical drug market. We, the people of the world, can no longer close our eyes to the fact that there is an industry willing to let millions of people die unnecessarily from preventable heart attacks and strokes, in order to increase the price of shares.



We have launched the international initiative, 21st Century Eradicating Heart Disease to counteract these unethical interest groups. I urge you to support this worldwide initiative with your signature. Talk about the aims of this initiative wherever you live and work.

It is clear that to accomplish the goal of eradicating heart disease we cannot rely on anyone else. We, ourselves, millions of people, have to liberate mankind from this epidemic. We can accomplish this goal, because we have a completely new understanding about health and disease of our human body at our disposal.

The foundation of this new understanding is Cellular Medicine, a health principle that everyone can understand and use. Health and disease are determined at the level of millions of body cells. The most frequent cause of malfunction of these cells is insufficiency of bioenergy. Like the motor of your car with too little oil, millions of cells in our body are running dry of essential bioenergy. The most important energy carriers that we get from our diet are vitamins, minerals, certain amino acids, and trace elements. Cardiovascular diseases are particularly frequent because this organ system is subject to high mechanical demands due to the continuous pumping function of the heart and blood circulation.

An optimum daily supplementation of vitamins and other essential bioenergy compounds can effectively prevent not only cardiovascular diseases, but also other chronic diseases.

In a similar way the causes of the most common diseases, like high blood pressure, heart failure, and irregular heartbeat are no longer a secret. They are the immediate results of long-term deficiency of our body cells of vitamins and other essential nutrients. During the next decade the competent application of Cellular Medicine will cut down the most common diseases to a fraction of their current numbers.



## Cellular Medicine is the Future

A comparison with conventional medicine underscores why Cellular Medicine is the medicine of the future: in the treatment of coronary heart disease conventional medicine today essentially offers mechanical solutions which are unable to correct the underlying problem. The deposits in the coronary arteries are either squeezed flat by means of a balloon catheter, or detoured by means of bypass surgery.

In contrast with conventional medicine, Cellular Medicine focuses on the natural correction of the underlying problem: the reversal of the deposits themselves. This is accomplished by providing the cells of the artery walls with vitamins and other bioenergy carriers in order to stimulate collagen production and natural healing processes.

The earlier picture also shows how important it is to stop the lie and deception campaign that vitamins and other natural substances are a way back to medieval times. Quite the opposite is true: vitamin therapy and Cellular Medicine are the prevention and basic therapies of the future. Think about the comparison in this picture. Isn't it impressive how our thinking has been manipulated in such a way that we accept expensive and dangerous repair intervention in our body? At the same time, we allow the pharmaceutical industry and their PR and lobby groups to spread lies about alleged side effects of natural substances and publicly question the documented healing power.

We have to realize that this confusion in public opinion is no coincidence and that it is deliberately used by the pharmaceutical industry and other interest



groups. The aim of this mass manipulation is to hide the true causes for health and disease for the people. By doing so, a false and fatal dependency upon this industry is created, which

leads the people to part with responsibility for their bodies and their health.

We also have to recognize that this dependency is the precondition for a billion-dollar business feeding on existing diseases. An effective health care reform start with us, the people, freeing ourselves from these dependencies. Vitamin research and Cellular Medicine enable everyone to take responsibility for their own health and lives to an extent unknown up to now.

A further impressive example of why the future of medicine belongs to Cellular Medicine is heart failure. Everyone knows people with shortness of breath, edema and chronic fatigue. If you are diagnosed with heart failure today, your chances of surviving the next five years are less than 50%! The only hope that conventional medicine can offer you is that a donor heart for a heart transplant is found in time, before you die.

Modern Cellular Medicine is a logical and convincing way out of this deadlock. The main cause of heart failure is

a chronic deficiency of bioenergy in millions of cells of the heart. The purpose of these cells is to maintain an optimum pumping function for the blood circulation. If this bioenergy is supplied in the form of vitamins and other natural energy carriers, heart failure is effectively treated by preventing the underlying problem. Heart transplants and drug therapies which only treat the symptoms of this condition become unnecessary. When Christian Barnard first transplanted a heart in 1967, this procedure was built up to a media spectacle, which was only rivaled by the landing on the moon. This important surgical technique that might be used in certain exceptional cases has also been abused to hide the true causes of this disease: chronic vitamin deficiency. The consequences for human health: in the last three decades over 100 million people died worldwide from the consequences of heart failure – a preventable health condition. At the same time, the pharmaceutical companies made millions of dollars selling pharmaceutical drugs, which are simply unable to correct and treat the underlying causes of heart failure.

Do you realize how powerful the interest of the pharmaceutical industry is to hide the facts and disguise the truth?

Joey, a former stewardess had her first heart transplant at the age of 20 because of acute heart failure. Five years later her health condition had deteriorated to the point where a second heart transplant had become necessary. This is when she started with the vitamin program we developed. After a few months her health condition had improved to an extent that the heart transplant could be canceled. Joey asked me to tell her story to everyone, and you will also find it documented in my new book, *Why Animals Don't Get Heart Attacks*.

Of course, there will always be a need for specialists who can conduct bypass surgery and heart transplants in severe cases. But this will be the exception. Bioenergy supply through vitamins will be the basic prevention and therapy for heart failure in the future.

## Solution to the Puzzle

Today I invite you to join us in our mission to eradicate heart disease. I am convinced that the truth will prevail against economically strong, but morally weak, interest groups. The next part of my presentation will provide you with insights into the milestones we have already passed in this historic process.

My 1991 scientific publication, *Solution to the Puzzle of Cardiovascular Disease*, laid the foundation of the new understanding of this health condition. For the first time it became clear that heart attacks and strokes are not actual diseases, but the direct consequence of chronic vitamin deficiency.

It also became clear that cardiovascular disease can be eradicated and will be essentially unknown in future generations.

At that time, I was Director of Cardiovascular Research at the Linus Pauling Institute in California, and I asked the two-time Nobel laureate to support these far-reaching conclusions as co-author. Linus Pauling happily agreed, because he saw his own life's work confirmed.

This scientific sensation quickly reached the executive offices of the pharmaceutical companies. It was immediately clear that if this discovery was understood by millions of people, a multi-billion dollar pharmaceutical drug market would inevitably collapse. As a countermeasure, the pharmaceutical companies decided to form a worldwide cartel in order to prevent by all means the further distribution of this information.

## Criminal Reaction of the Pharma-Cartel


To implement these unethical plans, the Pharma-Cartel maintains a legion of hired lobbyists. In Washington, D.C. alone, over 1,000 lobbyists work for the Pharma-Cartel, two lobbyists for each member of Congress. The figures are comparable for Germany. The mission of each lobbyist is to influence public opinion and legislation in the most important industrialized countries. All of this in the interest of the pharmaceutical cartel; day in, day out. Many opinion leaders in science and medicine are also affected by the influence of the pharmaceutical cartel.

The U.S. Academy of Science initially promised to publish the scientific breakthrough towards the "Solution to the Puzzle of Cardiovascular Disease." Due to the influence of the Pharma-Cartel within the Academy of Science, publication was cancelled only weeks later. The following argument was given: "As there is no puzzle in cardiovascular disease, there can be no solution either." That this unsolved puzzle continues to take every second human life in the U.S. and beyond had apparently escaped the attention of these gentlemen. We did not hesitate to publish our important publication in a Canadian Journal of Nutritional Medicine.

We left no other stone unturned to guarantee the rapid dissemination of this lifesaving information. We presented this new therapy about cardio-

vascular disease to more than a dozen pharmaceutical companies in order to improve human health on a worldwide scale, with the help of a strong partner. All pharmaceutical companies in 1991 said, "No" with the exception of one, Hoffmann-LaRoche, the world's largest manufacturer of vitamin C. In November, 1991, I introduced my work to the heads of research at the headquarters of the Roche Company in Basel, Switzerland. Roche immediately understood the worldwide importance of this medical breakthrough. Nevertheless, shortly thereafter they expressed that they were not interested in any collaboration. Hoffmann-LaRoche's official reason for declining was that they do not want to finance a medical breakthrough for its competition! What a remarkable excuse!

Five years later the world learned what had really happened: in expectation of a worldwide increased demand for vitamin C, lysine and other natural substances mentioned in my work, the Roche Corporation used this information for an artificial increase in the price of the raw materials for these natural substances. In addition, together with the German Bayer Corporation and the U.S. firm Archer-Daniels-Midland, Roche formed a cartel for criminal price fixing of the natural substances mentioned in our work. Isn't it remarkable that these pharmaceutical companies did not want to spend a single dime to spread the information about the eradication of heart disease?




At the same time, they made sure that they cannibalized this process by selling the raw material at prices that have almost doubled the retail price for these vitamin products.

On January 30th, 1997, the New York Times reported that U.S. federal prosecutors had uncovered the most comprehensive case of criminal price fixing in the history of the United States. According to U.S. prosecutors quoted in the New York Times, the dimension of this fraud was so vast that "literally hundreds of products and almost every consumer" was affected. A key witness stated that the criminal acts were designed at the highest level of the Roche, Bayer, and other corporations, and that the corporate masterminds were "the masters" whereas the subordinates who had to do the dirty work were called the "sherpas." All three companies were found guilty.

From here on everyone can describe Roche, Bayer, and the other pharmaceutical companies publicly as what they are: criminals, who have no scruples to profit at the expense of the health and lives of millions of people.

## The Rath / Pauling Manifesto

We also decided to inform the general public directly through the media. At a press conference on July 2, 1992, we presented the advances in vitamin research and the possible eradication of heart disease to the world. If the information about this medical breakthrough had not been suppressed by special interest groups for six long years, the entire world would know today that vitamins prevent heart attacks. If this information had been promoted instead of sabotaged, more than 60 million lives could have been spared from unnecessary, preventable heart attacks and strokes.



At this press conference we also introduced the Rath-Pauling Manifesto to the world. With his last public appeal, Linus Pauling supported the medical breakthrough of my scientific publications. This historic appeal ended with the sentence, "The goal of eliminating heart disease as the major cause of death and disability is now in sight." This sentence marks a turning point in medicine.


## A Historical Success for the People of America

The pharmaceutical companies reacted immediately through the United States Food and Drug Administration (FDA). A nationwide campaign was started to prohibit all health claims in relation to vitamins and other natural substances.

This does not surprise anyone who knows that essentially all reviewers and advisors of the FDA are paid employees of pharmaceutical companies. I recommend everyone to read Thomas Moore's book, *Deadly Medicine*, revealing the fact that the FDA is essentially controlled by the pharmaceutical industry. The pharmaceutical companies, realizing that the information about the eradication through vitamins could not be stopped any other way, decided to achieve their aims by simply changing the law. 1993 was also the year that my book, *Eradicating Heart Disease* was pub-

lished in the U.S.A. It summarized the medical breakthrough in vitamin research and heart disease in popular language. Tens of thousands of Americans used this book and other studies on the health benefits of vitamins to convince their political representatives not to give in to the unethical plans of the pharmaceutical industry and the FDA. Newsweek described this fight for free access to vitamins as "the largest movement since the Vietnam war" Again, the interests of the people prevailed over apparently overwhelming economic interests.

In August, 1994, the US Senate and House of Representatives unanimously passed the Nutritional Health and Education Act, a monumental law preserving and guaranteeing free access to vitamins and other natural health products. This law did not simply maintain the status quo; it also allows truthful health information in relation to vitamins to be distributed. From a historical point of view, a popular



movement of millions of Americans had just inflicted the worst defeat in their history upon the pharmaceutical companies and their interest groups. More importantly, millions of Americans had won a historic victory from which all of mankind will benefit.

## "Codex Alimentarius"

Unfortunately, the pharmaceutical companies did not give in, even though America, the most powerful country in the world, had started to liberate itself from the yoke of the pharmaceutical interests. Led by the German pharmaceutical companies and under the political auspices of the German government, the international pharmaceutical consortium started its latest offensive. They activated a so-called expert commission of the United Nations with the mysterious name, "Codex Alimentarius."

This commission held a clandestine meeting under German presidency and guidance in Bonn, Germany, in October 1996. The official participation of high-level representatives of the German government (Departments of Health and Human Services and Agriculture) showed that the aims of this commission have the support of the German cabinet and Chancellor, a case of highest priority for Chancellor Kohl. Against the votes of the United States, Canada, the Netherlands, and representatives of other countries, the German delegation pushed the following decisions through:

All health statements in relation to the preventive and therapeutic effects of vitamins and other natural substances shall be prohibited for all member countries of the United Nations, that is, worldwide.

Only those natural vitamins and other natural products that meet the much too low so-called daily allowances of the pharmaceutical cartel can be sold in the future.

Countries resisting the implementation of these decisions as binding laws are to be punished by international economic sanctions organized under the United Nations World Trade Organization and other bodies.

The German government had taken precautions in case the activities of this clandestine "Codex" Cartel were revealed prematurely: the presidency of this Codex Commission was assigned to Dr. Somogyi: the head of the German federal agency for consumer protection. The politicians in Bonn were well aware of the explosive power of this commission, and therefore decided to cover up this enterprise as "consumer protection" in order to deceive the public about the true nature of the "Codex" Cartel.

In January 1997 we talked about the goals of the Codex commission to United States Congressman Peter de Fazio, an advocate for vitamin freedom. Of particular interest was the threat of economic sanctions against those countries that did not comply with the "Codex" Cartel. By imposing economic sanctions the Pharma-Cartel wants to force all other industries at its side. The motto of the Pharma-Cartel appears to be "If you, Microsoft, Volkswagen, and Sony, do not support the information boycott for vitamins, we will make sure that within the framework of the Codex law, you will not be able to sell your software, cars, and electronic products in other countries."



We have to realize that the Pharma-Cartel and its political accomplices apparently declared war on the health and life interests of all mankind. Because the interests of the Pharma-Cartel are against the health interests of entire mankind, the battle will be fierce; therefore, the Cartel tries to force other industries behind its unethical plans by means of laws.

Our answer is clear: these unscrupulous and unethical plans are not a sign of strength of the pharmaceutical companies, but a sign of desperation. The news that animals don't get heart attacks because they manufacture their own vitamin C will bring down a billion dollar market in cholesterol-lowering drugs, beta blockers, calcium antagonists, and other cardiovascular drugs.

Our determined "No" to these unethical human plans is summarized in the Petition for Vitamin Freedom. I encourage you to talk with friends, neighbors, and colleagues about the Codex Commission, and let them sign the Petition for Vitamin Freedom.

Together, we will prevent the unethical plans of the Pharma-Cartel.

**Why Germany (again)?**


When looking at the global intrigues of these special interest groups, one question comes to mind: why is it that in these plans, which inevitably will endanger the health and lives of millions of people, do the German pharmaceutical industry and the German government play leading roles? Every visitor to the Frankfurt airport in Frankfurt/Main, Germany, can guess the worldwide influence of the German pharmaceutical and chemical industry.

The majority of the signs at the official corporate meeting point at the airport belong to pharmaceutical companies; a kind of business card of the German industry. But this is only the surface. To understand the global key role of the German government in connection with the Codex Commission, we have to consider the close entanglement between the German government and the German chemical and pharmaceutical industry throughout this century.

War and of the plundering of Europe by the Nazis. One hundred percent of all explosives and synthetic gasoline came from the factories of the IG Farben. Whenever the German Wehrmacht conquered another country, Bayer, Hoechst and BASF executives followed, systematically taking over the industries of these countries. Through this close collaboration with Hitler's Wehrmacht, IG Farben participated in the plunder of Austria, Czechoslovakia, Poland, Norway, Holland, Belgium, France and all other countries occupied by the Nazis. In 1946, the U.S. government investiga-

tion concluded that without the IG Farben the Second World War would simply not have been possible. We have to realize that it was not a psychopath named Adolf Hitler, nor the innate character of the German people that brought about the Second World War. Economic greed by companies like Bayer, BASF and Hoechst was the key factor in bringing about the Holocaust.

No one who saw Steven Spielberg's film "Schindler's List" will forget the scenes in the concentration camp Auschwitz. Auschwitz was the largest mass extinction factory in human history, but the concentration camp was only the appendix. The main project was IG Auschwitz, a 100% subsidiary of IG Farben, the world's largest industrial complex for manufacturing synthetic gasoline and rubber for the conquest of Europe. On March 1st, 1941, Heinrich Himmler, the Reichsführer of the SS, inspected the construction site. On April 14th, 1941 Otto Ambros, the IG Farben board member responsible for the Auschwitz project, rose to his IG Farben board colleagues in Ludwigshafen and stated, "our new friendship with the SS is a blessing. We have determined all measures integrating the concentration camps to benefit our company." The pharmaceutical departments of the IG Farben cartel used the victims of the concentration camp in their own way: thousands of them died during human experiments such as the testing of new and unknown vaccines.




**The IG Farben - Cartel**

The most powerful German corporate imperium in the first half of this century was IG Farben, short for Interessengemeinschaft Farben. Interessengemeinschaft stands for association of common interests and was a powerful cartel of BASF, Bayer, Hoechst, and other chemical and pharmaceutical German companies. The IG Farben was the single largest donor to the election campaign of Adolf Hitler.

One year before Hitler seized power in 1933, IG Farben donated 400,000 marks to Hitler and his Nazi party. Accordingly, when the Nazis came to power the IG Farben was the single largest profiteer of the Second World

There was no retirement plan for the prisoners of the IG Auschwitz. Those too weak or too sick to work were selected at the main gate of the IG Auschwitz factory and sent to the gas chambers. Even the chemical gas Zyklon-B, used for the annihilation of millions of people, came from the drawing boards and factories of the IG Farben.



The Nuremberg War Criminal Tribunal convicted 24 IG Farben board members and executives for mass murder, slavery and other crimes against humanity. Amazingly however, by 1951 all of them had been released and were working for German Corporations again.

The Nuremberg Tribunal divided the IG Farben into Bayer, Hoechst, and BASF. Today each of the three daughters of the IG Farben is 20 times as big as the IG Farben mother was at its height in 1944, the last year of the Second World War. More importantly, the chairmen of the boards, the highest positions in BASF, Bayer and Hoechst, were occupied by former members of the Nazi-Party for almost three decades after the Second World War.

- Carl Wurster, chairman of the board of BASF until 1974, was on the board of manufacturers of Zyklon-B gas during the war.
- Carl Winnacker, chairman of the board of Hoechst until the late 70's

was a member of the Sturm Abteilung (SA) and was a member of the IG Farben board.

- Curt Hansen, chairman of the board of Bayer until the late 70's, was co-organizer of the conquest of Europe in the department of "acquisition of natural resources." Under this leadership the IG Farben daughters, BASF, Bayer, and Hoechst, continued to support politicians representing their interests. During the 1950's and 60's they invested in the political career of a young representative from a suburb of the BASF town of Ludwigshafen: Helmut Kohl. From 1957 to 1967 the young Helmut Kohl was a paid lobbyist of the Verband Chemischen Industrie, the central lobby organization of the German pharmaceutical and chemical cartel. Thus, the German chemical and pharmaceutical industry built up one of their own as a political representative leaving to the German people only the

choice of approval. The result is well known: Helmut Kohl was chancellor of Germany for 16 years and the German pharmaceutical and chemical industry became the leading exporters in the world with subsidiaries in over 150 countries, more than the IG Farben ever had.

Germany is the only country in the entire world in which a former paid lobbyist for the chemical and pharmaceutical cartel was head of the government. In summary the support of German politics for the global expansion plans of the German pharmaceutical and chemical companies has a 100-year tradition. It is with this background that we understand the support of Bonn for the unethical plans of the Codex Commission.

The U.S. head prosecutor in the Nuremberg War Criminal Tribunal against the IG Farben anticipated this development when he said: "These IG Farben criminals, not the lunatic Nazi fanatics, are the main war criminals. If the crimes of these criminals are not brought to daylight and if they are not punished, they will represent a much greater threat to the future peace of the world than Hitler if he were still alive."

Twice during this century, indescribable and worldwide grief originated from German soil. If, with the help of German politicians, the Pharma-Cartel prevails, the eradication of heart disease will be prevented, and in the next generation alone, over 500 million people unnecessarily will die from heart attacks.

## Learn from History

Twice this century the people in Germany have kept their mouths shut until it was too late. This cannot happen a third time. We, the people of Germany, now have a chance to prove to the entire world that we have learned from history.

Now the German government is involved for the third time in acts that affect the health and lives of millions of people world wide. But this time we will speak out!

We will keep our political representatives on their toes until the German government prohibits any future participation of political or corporate representatives in the Codex Commission. Those political representatives who do not listen to us will be voted out of office next year. It's that easy! We won't forget that: "We are the people!"

## Pharmaceutical Industry Deceives the General Public


The pharmaceutical industry continues to control our society. Pharmaceutical interests control medical research, and have entire health professions dependent. To maintain and secure their position of power, the pharmaceutical companies manipulate the legislation and the media. In large-scale advertising campaigns through all media, the pharmaceutical PR and propaganda department creates a smoke screen concealing the true interests of the pharmaceutical industry.

The pharmaceutical companies try to portray themselves in the light of Louis Pasteur, Robert Koch and other pioneers in medicine. They claim to be interested in the eradication of diseases in order to serve humanity. The truth, however, is the exact opposite: the pharmaceutical industry is interested in keeping diseases alive as a basis for an expanding pharmaceutical drug market. The goals of the Codex Cartel deliberately obstruct the eradication of diseases. Thus, the pharmaceutical industry does not act in the tradition of the saviourhood of humanity, but in the tradition of the IG Farben, a group of organized criminals willing to sacrifice countless human lives in order to maintain their profits.

In other deceptive advertisements the pharmaceutical industry claims that the eradication of infectious diseases is their merit. Fact is, however, that the most important treatments of infectious diseases, as well as penicillin and other antibiotics, were discovered at publicly financed universities. The only credit the pharmaceutical indus-

try deserves is that they immediately tried to use these discoveries for their own profit. Millions of people and taxpayers were defrauded: they not only paid for the research at public universities, but on top of that, they had to pay for the drugs developed with public funds but marketed by pharmaceutical companies.

In other deceptive PR campaigns, the pharmaceutical companies claim that with their help, life expectancy has doubled throughout this century. However, the fact is that every medical textbook documents that this progress is the result of better hygiene and has nothing to do with antibiotics and other pharmaceutical drugs. What a lie, considering the fact that the pharmaceutical cartel is trying to ban health information for vitamins, fully aware of the fact that by doing so, they shorten the life expectancy of millions of people by decades.



A further deception of the public is the campaign for cholesterol-lowering drugs. Millions of hibernating animals have cholesterol levels of 400 mg to 600 mg per deciliter, yet they don't get heart attacks because they stabilize their artery walls with sufficient vitamins which they produce in their own bodies, or take up in the diet. The connection between cholesterol and heart disease obviously is another illusion

maintained by the manufacturers of cholesterol-lowering drugs.

The only thing we know for sure about cholesterol-lowering drugs is that all of them can cause cancer. In January 1996, the Journal of the American Medical Association alerted the medical community and the general public about the fact that cholesterol-lowering drugs have caused cancer in dosages close to those currently swallowed by millions of people worldwide. The pharmaceutical companies are not impressed by these facts. In large-scale TV spots and advertising campaigns they continue to sell these cancer time bombs as if they were lollipops or chewing gum.

On June 23rd, 1997, Fortune magazine, one of the major Wall Street weeklies, carried an article about the health care system. It contained an interview with an investment consultant for pharmaceutical companies who claimed that "everyone loses if eradication therapy catches on." With "everyone" he, of course, does not mean you or millions of patients. This consultant simply stated what everyone on Wall Street knows: the research and therapeutic decisions within the pharmaceutical companies are guided by the financial interests of the shareholders.

The profits of the pharmaceutical companies during the past 25 years were on average 500% percent above the average of all industry branches. In other words the business with ongoing diseases is the most lucrative business in the world, and millions of people pay the bill, directly and indirectly. The exploding health care costs, paid for by the people and the patients, are nothing but the insatiable greed of the pharmaceutical companies.

## What Do We Have to Do?

These facts underscore the necessity for an entirely new structure of the health care system. Every day that we allow these unscrupulous practices to continue, thousands of people pay with their lives. What can we do?

In the United States the Attorneys General of 34 states sued the cigarette manufacturers in order to recover the health care costs caused by cigarette smoking. The cigarette giants started to shake in their boots, and they face an ultimate fine of over \$400,000 million dollars to make up for damages

caused by their product. Of course, they knew all along about the crimes they had committed. If I am not mistaken, the damage caused by pharmaceutical corporations to millions of patients and to the public sector of essentially every country in the world, exceeds the damage done by tobacco several times.

The most important step to change things is that we not only denounce abuses, but that we take part in constructing a new health care. Once we have liberated ourselves from the yoke of the pharmaceutical cartel, the

prospects for improvement of human health are breathtaking. Within the next few generations most common diseases can be controlled and the average life expectancy can increase by ten years or more. Growing older in full physical health will be the rule, not the exception.

I have asked myself whether there has ever been a parallel situation in human history where the people had to liberate themselves from such an ever-present suffocating grip by a small but powerful interest group. Here is this historic parallel...

# The Chemnitz Program

- 1 **We**, the people of this Earth, are aware that at the end of the 20th Century we still have completely inadequate knowledge of our bodies and of the causes of good health and disease. Physical incapacity is today forcing millions of people into disastrous physical and financial dependency on interest groups which profit from the continued existence of disease, principal among them being the pharmaceutical industry.
- 2 **The** corporate purpose of the pharmaceutical industry is the trade in disease, not the prevention or eradication of disease. The pharmaceutical industry has a direct financial interest in the continued existence of disease as the prerequisite for the continuing growth of pharmaceutical markets.
- 3 **The** pharmaceutical industry's most lucrative business comes from those diseases that are most widespread. The pharmaceutical industry itself is the main obstacle to medical breakthrough in the control of cardiovascular disease, high blood pressure, cardiac insufficiency, cancer, osteoporosis and other endemic public health scourges.
- 4 **The** trade in disease is one of the most profitable trades there is. The profits made by the pharmaceutical industry are several times greater than the average for other industries. These pharmaceutical industry profits are the main reason for skyrocketing health-care costs. The economies of virtually all industrialized countries in the world are in the stranglehold of the pharmaceutical industry.
- 5 **We**, the people of this Earth, are doubly damaged by this state of affairs. Firstly, we have to meet the skyrocketing health-care costs either directly or indirectly. Secondly, we receive no return on our money in the form either of good health or the control of endemic public health problems.
- 6 **In** the face of express resistance from the pharmaceutical industry, a medical breakthrough has now been achieved which will lead to cardiovascular diseases being brought under control. Heart attack and stroke are not true diseases, they are the consequences of chronic vitamin deficiency – and as such are preventable.
- 7 **Now** that humanity has the unique opportunity to free itself from the scourge of heart disease, pharmaceutical companies are forming a worldwide cartel designed to prevent this happening. To achieve their aims the pharmaceutical companies are willing to accept the continuing existence of cardiovascular disease and the premature deaths of millions of people.
- 8 **These** activities have laid bare the pharmaceutical industry's true agenda for all the world to see. We, the people of this Earth, are no longer prepared to subject ourselves to the yoke of this immoral interest group.
- 9 **We** declare that the pharmaceutical industry, whose business is founded on the maintenance of disease, is unethical and incompatible with the fundamental principles of human rights. We demand immediate legal steps to ban this industry from conducting its business.
- 10 **The** intentional maintenance of disease in order to promote sales of drugs and the prevention of the eradication of disease have as a consequence the death of millions of people. In view of the scale of this crime they must be punished with the most severe penalty available under prevailing law, and further laws must be passed by the nations of the world without delay. At international level these misdeeds must immediately be pursued as criminal violations of human rights.
- 11 **Existing** pharmaceutical companies must be subjected to immediate investigation into the extent to which they have enriched themselves from the deliberate maintenance of disease and prevention of its eradication. If the pharmaceutical companies are found guilty of this crime, their assets must be seized in payment of damages to affected parties and the community generally.
- 12 **Politicians** and other accomplices who are guilty of aiding and abetting crimes of this sort must be called to account before the courts of law.
- 13 **Laws** preventing free access to and use of vitamins and other natural therapies must be repealed.
- 14 **Above** all, this programme lays the foundations for a new system of health care. As a first step, the preservation and improvement of health will be declared an inalienable human right.
- 15 **The** primary goal of the new health care system will be the prevention and eradication of disease. Vitamin research and Cellular Medicine constitute a sound scientific basis for the implementation of effective, side-effect free and economical health care measures.
- 16 **We**, the people of this Earth, declare that we will build up this new system of health care and that we ourselves will form the cornerstones of this new system.
- 17 **The** foundation of this new system of health care is the provision of comprehensive public information and education on health care issues. In every town and city, information and advice centers will be set up through which committed lay persons and members of the healing professions can contribute to the creation of this new system.
- 18 **The** training of existing health professionals will be extended and new health professions will be created with the goal of guaranteeing basic grass-roots health care.
- 19 **Health-care** education will be made a compulsory subject in schools and the further education of the public on health-care issues will be promoted at all levels.
- 20 **Medical** research and licensing of drugs will be subjected to a comprehensive system of public control.

From this meeting here in Chemnitz we call upon the people of Germany, Europe and the world: support this program and implement it in your town and your country. Do it for your own health and for the health of future generations. We call upon everyone to vote only for politicians who support this program and help to fulfill it. Do not trust any politician who functions as a puppet of the Pharma-Cartel.

*Ladies and gentlemen, as you leave, take a deep breath and enjoy the feeling that a new era has begun. No one can accomplish the mission that lies before us, but ourselves.*

# The Hague Complaint

# The Hague Complaint

## Introduction

On June 14, 2003 our Foundation lodged formal charges against those special interests behind the pharmaceutical business with disease at the International Criminal Court (ICC) in The Hague, the Netherlands. The ICC is the premier world court for cases of genocide and other crimes against humanity.

We are convinced that one day soon these charges will form the basis for an international tribunal at the ICC that will shadow the scope of the Nuremberg Pharma Tribunal of 1947/48.

Following is the text of the charges and a summary of the main evidence from the original document.

### **The Cartel**

The charges presented in this complaint relate to two main fields of crime:

- \* Genocide and other crimes against humanity committed in connection with the pharmaceutical business with disease.
  
- \* Crimes of war and aggression and other crimes against humanity committed in connection with the recent war against Iraq and the international escalation towards a world war.

These two fields of crime are directly related and connected by one factor: They are committed in the name and interest of the same corporate investment groups and their political stakeholders. In order to establish the evidence and show the common motives of the accused a short historical review is imperative.

Throughout the 20th century, the pharmaceutical industry was built and organized with the goal of controlling healthcare systems around the world by systematically replacing natural, non-patentable therapies with patentable and therefore profitable synthetic drugs. This industry did not evolve naturally. To the contrary, it was an investment decision taken by a handful of wealthy and unscrupulous entrepreneurs. They deliberately defined the human body as their market place in order to generate further wealth.

The driving force of this investment industry was the Rockefeller Group. They already controlled more than 90% of the petrochemical business in the United States at the turn of the 19th to the 20th century and they were looking for new global investment opportunities. Another investment group active in this field was formed around the Rothschild financial group.

### **The Cartel and the Second World War**

After Rockefeller's Standard Oil (today EXXON), the second largest pharmaceutical/petrochemical corporate conglomerate during the first half of the 20th century, was the IG Farben conglomerate headquartered in Germany. This corporate conglomerate was the single most important factor for the political rise to power of Hitler and their joint conquest of Europe and the world. In fact, the Second World War was a war of aggression planned, started and conducted on the plan-

ning boards of IG Farben. IG Farben was the parent company of IG Auschwitz, the largest Industrial plant of this chemical cartel outside Germany. Much of the wealth of this cartel was built upon the blood and suffering of slave laborers, including those from the Auschwitz concentration camp. IG Farben promoted and used the unscrupulous political rulers of Germany as their willing tools to seek economic dominance over Europe and the rest of the world.

IG Farben was the largest shareholder in Rockefeller's Standard Oil and vice versa. The victory of the Allied Forces over Nazi-Germany at that time terminated the plans of IG Farben to become the leading pharmaceutical and petrochemical conglomerate in the world. At the same time, Standard Oil and the other pharmaceutical/petrochemical corporations of the Rockefeller consortium became the controlling financial group of this industry and remained so ever since.

In the Nuremberg War Tribunal of 1947 against the managers of the IG Farben Cartel several of them were found guilty and convicted for committing crimes against humanity including mass murder, plundering and other crimes. The Nuremberg War Tribunal also dismantled the IG Farben Cartel into the daughter companies Hoechst, Bayer and BASF. Today, each of these companies is larger than the parent company IG Farben was at that time.

Today the United States of America and Great Britain are the leading export nations of pharmaceutical products in the world. In fact, two out of three pharmaceutical drugs currently marketed globally derive from corporations in these two countries.

## **Fundamentals of the Pharmaceutical Business**

The accused are responsible for the deaths of hundreds of millions of people who continue to die from cardiovascular disease, cancer and other diseases that could have been prevented and largely eliminated long ago.

This premature death of millions of people is neither the result of coincidence nor negligence. It has been willfully and systematically organized on behalf of the pharmaceutical industry and its investors with the sole purpose to expand a global drug market worth trillions of dollars.

The market place of the pharmaceutical industry is the human body and its return on investment depends on the continuation and expansion of diseases. Its profits depend on the patentability of drugs rendering this industry the most profitable industry on planet Earth.

In contrast, the prevention and eradication of any disease significantly reduces or totally eliminates the markets for pharmaceutical drugs. Therefore, the pharmaceutical corporations have been systematically obstructing the prevention and the eradication of diseases.

To commit these crimes, the pharmaceutical corporations use a maze of executors and accomplices in science, medicine, the mass media and in politics. The governments of entire nations are manipulated or even run by lobbyists and former executives of the pharmaceutical industry. For decades, the legislation of entire nations has been corrupted and abused to promote this multi-trillion-dollar "business with disease" thereby risking the health and lives of hundreds of millions of innocent patients and people.

A precondition for the rise of the pharmaceutical industry as a successful investment business was the elimination of competition from safe and natural therapies because they are not patentable and their profit margins are small. In addition, these natural therapies can effectively help prevent and eliminate diseases because of their essential roles in cellular metabolism.

As the result of the systematic elimination of natural health therapies and the takeover of the healthcare systems in most countries of the world, the pharmaceutical industry has brought millions of people and almost all nations into dependency upon its investment business.

## **Pharmaceutical Industry as an Organized Fraud Business**

The pharmaceutical industry offers “health” to millions of patients – but does not deliver the goods. Instead it delivers products that merely alleviate symptoms while promoting the underlying disease as a precondition for its future business. To cover the fraud, this industry spends twice the amount of money in covering it up than it spends on research on future therapies.

This organized deception is the reason why this investment business could continue for almost a century behind a strategically designed smoke screen as ‘benefactors’ to humanity. The lives of 6 billion people and the economies of most countries in the world are held hostage by the criminal practices of this industry.

## **Exposing the Pharmaceutical ‘Business with Disease’**

Over the past decade, I have led the effort to unmask the organized fraud of this largest investment industry on earth. I have been instrumental in pointing out that the biggest obstacle for improving the health of the people of our planet is the pharmaceutical industry itself - and its nature as an investment industry driven by the expansion of diseases.

As a scientist, I was privileged to discover the true cause of cardiovascular disease and other chronic diseases. Together with my colleagues and others I have also been instrumental in documenting the effective, natural and non-patentable alternatives to the pharmaceutical ‘business with disease.’ The identification of the natural molecules that optimize cellular metabolism enables mankind to prevent and largely eliminate most of today’s most common diseases including cardiovascular disease, cancer and many others.

## **Background of the Current International Crisis and the War of Aggression Against Iraq**

Four main factors are currently threatening the survival of the pharmaceutical industry and thereby the very basis of a long-term investment industry worth hundreds of trillions of dollars:

1. Unsolvable legal conflicts, resulting in an avalanche of class action lawsuits against many pharmaceutical corporations for product liability
2. Unsolvable scientific conflicts due to the breakthroughs in natural, non-patentable therapies that effectively and largely eradicate diseases as a market place.
3. Unsolvable ethical conflicts, resulting in the loss of credibility for the entire pharmaceutical business due to the fact that their exorbitant patent fees limit access to medicines for the majority of people and risk premature death for millions.
4. Unsolvable corporate conflicts. The unmasking of the pharmaceutical business model as an organized fraud.

For decades, the Pharma-Cartel has made every effort to protect its global business with patented drugs and to ban the dissemination of competing non-patentable health alternatives. This effort is conducted at the international level, by infiltration of the European Parliament and the abuse of the World Health Organization and other United Nations Organizations.

Now, with the largest investment industry on planet Earth being exposed as an organized fraud business - haunted by tens of thousands of liability lawsuits - immediate and global industry protection laws have become an urgent measure

to cover up these crimes and to cement the continued control of the investment “business with disease” over human health worldwide.

These far-reaching protection laws for an organized fraud-business implied the curtailing of civil rights and other drastic measures that could not be implemented during peacetime. The implementation of these measures required the escalation of an international crisis, a series of military conflicts that deliberately factors in the use of weapons of mass destruction and the triggering of a World War. Only then would there exist a global psychological situation that would allow abandonment of civil rights, passing of martial laws and the global implementation of protection laws allowing the accused to continue their ‘business with disease’ and other crimes.

In this situation, the pharmaceutical industry became the single largest corporate donor to the election of George Bush in order to exert direct influence over the most powerful political and military center in the world. With the election of George Bush, the Rockefeller investment group had direct access to the White House, the Pentagon and the political decisions taken there. A similar influence was exerted by the Rothschild group on the government of Tony Blair in Great Britain.

Thus, it was no surprise that the two largest export nations of pharmaceutical products, the United States of America and Great Britain, spearheaded the current international crisis and instigated the war against Iraq. The alleged necessity for this war was presented to the people in America, Great Britain and the world under the false pretence of a global fight against ‘terrorism’, elimination of rogue governments and the crusade against proliferation of weapons of mass destruction.

Thus, the same corporate interest groups and the same political stakeholders responsible for millions of deaths from the continued business with disease are now also responsible for risking the unnecessary death of tens of thousands of innocent people in Iraq and for the death of young soldiers in America, Great Britain and other countries. They are responsible for starting and conducting a war of aggression against Iraq without any international mandate. They are responsible for the enslavement, plunder and other crimes currently being conducted in occupied Iraq.

If these interest groups and their political stakeholders are not held accountable for these crimes immediately, they are likely to continue the escalation of the international crisis with the ultimate risk of a war with weapons of mass destruction.

In this critical and historical situation I am bringing these crimes against humanity, these war crimes and crimes of aggression and of genocide to the attention of the prosecutor at the International Criminal Court and urge him to take immediate action to prevent further crimes and the ultimate disaster, a world war.

Every individual person, government, corporation or organization from anywhere in the world who has suffered from these crimes or wishes to terminate these crimes is called upon to join this complaint.

## Criminal Charge

The charges in this complaint relate to crimes in two main fields:

- \* Crimes perpetrated by the pharmaceutical “business with disease” including the crime of genocide and other crimes against humanity.

\* Crimes related to the 2003 war against Iraq and the international escalation towards a world war including crimes of war and aggression as well as other crimes against humanity.

These two fields of crime are directly connected because they are committed in the name and interest of the same corporate investment groups and their political stakeholders. The accused are charged with the most serious crimes committed against all mankind and are therefore subject to the principle of international prosecution.

## **1. Crimes Committed In Connection With The Pharmaceutical 'Business With Disease'**

### **1.1. The Crime of Genocide**

The accused are guilty of the crime of genocide for which they are liable to prosecution under Article 6 of the ICC Statute. This includes but is not limited to the following specific crimes:

1.1.1. Genocide by Killing (Article 6a)

1.1.2. Genocide by causing serious bodily or mental harm (Article 6b)

1.2.3. Genocide by deliberately inflicting conditions of life calculated to bring about physical destruction (Article 6c)

### **1.2. Crimes Against Humanity**

The accused are guilty of the crime of genocide for which they are liable to prosecution under Article 7 of the ICC Statute. This includes but is not limited to the following specific crimes:

1.2.1. Crime Against Humanity of Murder (Article 7a)

1.2.2. Crime Against Humanity of Extermination (Article 7b)

1.2.3. Crime Against Humanity of Enslavement (Article 7c)

1.2.4. Crime Against Humanity of Severe Deprivation of Physical Liberty (Article 7e)

1.2.5. Crime Against Humanity of Other Inhumane Acts (Article 7k)

## **Summary Of The Substantiation Of The Charges In Relation To The Crimes Connected With The Pharmaceutical 'Business With Disease' (Charges 1.1. - 1.2.)**

1. The accused willfully and systematically maintain cardiovascular diseases, including high blood pressure, heart failure, diabetic complications and other diseases, cancer, infectious diseases including AIDS, osteoporosis and many other of today's most common diseases that are recognized to be largely preventable by natural means. The accused have deliberately caused the unnecessary suffering and premature death of hundreds of millions of people.
2. The accused systematically and deliberately prevent the eradication of cardiovascular disease, cancer and other diseases by obstructing and blocking the dissemination of life-saving information on the health benefits of natu-

ral non-patentable therapies. Thereby, the accused have deliberately caused further unnecessary suffering and the premature death of hundreds of millions of people.

3. The accused deliberately and systematically expand existing diseases and creating new diseases by manufacturing and marketing pharmaceutical drugs with short-term symptomatic relief but with known and detrimental long-term side-effects. Thereby the accused have deliberately caused further unnecessary suffering and premature death of hundreds of millions of people.

## **2. Specific Crimes Committed In Connection With The War Against Iraq And The Current International Crisis**

### **2.1. The Crime of Genocide**

The accused are guilty of the crime of genocide for which they are liable to prosecution under Article 6 of the ICC Statute. Under the terms of this statute genocide means any of the following acts committed with intent to destroy, in whole or in part, a national, ethnic, racial or religious group. This includes but is not limited to the following specific criminal charges:

- 2.1.1. Genocide by killing (Article 6a)
- 2.1.2. Genocide by causing serious physical or mental harm (Article 6b)
- 2.1.3. Genocide by deliberately inflicting living conditions calculated to bring about physical destruction (Article 6c)

### **2.2. Crimes Against Humanity**

Under the terms of Article 7 of the Rome Statute, crimes against humanity mean any of the following acts when committed as part of a widespread or systematic attack directed against any civilian population, with knowledge of the attack. This includes but is not limited to the following specific criminal charges:

- 2.2.1. Crimes against humanity of murder (Article 7a)
- 2.2.2. Crimes against humanity of extermination (Article 7b)
- 2.2.3. Crimes against humanity of enslavement (Article 7c)
- 2.2.4. Crimes against humanity of deportation or forcible transfer of population (Article 7d)
- 2.2.5. Crimes against humanity of imprisonment or other severe deprivation of physical liberty (Article 7e)
- 2.2.6. Crimes against humanity of other inhumane acts of a similar nature intentionally causing great suffering, or serious injury to the body or to mental or physical health. (Article 7k)

### **2.3. War Crimes**

Under the terms of Article 8 of the Rome Statute, war crimes mean grave breaches of the Geneva Conventions of 12th August 1949 (Geneva Convention on the Treatment of Prisoners of War, Geneva Convention for the Protection of Civilian Persons in Times of War). War crimes under the terms of the Statute therefore include but are not limited to:

- 2.3.1. War crime of wilful killing (Article 8(2)(a)(i))
- 2.3.2. War crime of torture (Article 8(2)(a)(ii)-1)
- 2.3.3. War crime of inhuman treatment (Article 8(2)(a)(ii)-2)
- 2.3.4. War crime of including biological experiments (Article 8(2)(a)(ii)-3)
- 2.3.5. War crime of wilfully causing great suffering (Article 8(2)(a)(iii))
- 2.3.6. War crime of destruction and appropriation of property (Article 8(2)(a)(iv))
- 2.3.7. War crime of denying a fair trial (Article 8(2)(a)(vi))

- 2.3.8. War crime of unlawful deportation and transfer (Article 8(2)(a)(vii)-1)
- 2.3.9. War crime of unlawful confinement (Article 8(2)(a)(vii)-2)
- 2.3.10. War crime of taking hostages (Article 8(2)(a)(viii))
- 2.3.11. War crime of attacking civilians (Article 8(2)(b)(i))
- 2.3.12. War crime of attacking civilian objects (Article 8(2)(b)(ii))
- 2.3.13. War crime of excessive incidental death, injury or damage (Article 8(2)(b)(iv))
- 2.3.14. War crime of attacking of undefended places (Article 8(2)(b)(v))
- 2.3.15. War crime of killing or wounding a person outside combat (Article 8(2)(b)(vi))
- 2.3.16. War crime of mutilation (Article 8(2)(b)(x)-1)
- 2.3.17. War crime of destroying or seizing the enemy's property (Article 8(2)(b)(xiii))
- 2.3.18. War crime of depriving the nationals of hostile power of rights (Article 8(2)(b)(xiiv))
- 2.3.19. War crime of employing poison or poisoned weapons (Article 8(2)(b)(xvii))
- 2.3.20. War crime of employing prohibited bullets (Article 8(2)(b)(xix))
- 2.3.21. War crime of outrages upon personal dignity (Article 8(2)(b)(xxi))
- 2.3.22. War crime of starvation as a method of warfare (Article 8(2)(b)(xxv))
- 2.3.23. War crime of murder (Article 8(2)(c)(i)-1)
- 2.3.24. War crime of cruel treatment (Article 8(2)(c)(i)-3)

### **Summary Of The Substantiation Of The Charges In Relation To The Crimes Connected To The War Of Aggression Against Iraq And The Current International Crisis (Charges 2.1.1 - 2.3.24)**

1. The accused deliberately started a war of aggression against Iraq without any mandate by international law.
2. The accused deliberately escalate an international crisis situation including psychological warfare and actual military warfare. The goal of this escalation strategy is to create a global emergency state that allows the abandonment of civil rights on global scale – including establishment of far reaching protectionist laws. The war of aggression against Iraq on the false pretence of a global fight against “terrorism” and the crusade proliferation of weapons of mass destruction is part of this strategy.
3. The accused deliberately committed the crimes of genocide, murder, mutilation and other serious bodily and mental harm during their war of aggression against the people of Iraq.
4. The accused deliberately committed the crime of destroying and seizing public and private property during and after the war of aggression. Iraq has the second largest oil resources in the world and these resources are being plundered on behalf of the accused for private gain.

### **HISTORIC PRECEDENT FOR THIS COMPLIAN**

The Nuremberg War Tribunal against executives of the pharmaceutical/petrochemical cartel IG- Farben

More than half a century ago, the Nuremberg War Tribunal took place against the executives of the IG Farben Corporation, the largest pharmaceutical-petrochemical cartel in pre-world-war Europe. The Nuremberg War Tribunal brought to justice those responsible for the Second World War and set the precedent for international prosecution of war crimes and ultimately the International Court in The Hague.

Unbeknown to most people today, the Nuremberg War Tribunal did not only sentence the political and military leaders, but also the corporate executives who brought Hitler to power. 24 executives and managers of IG Farben were indicted in this War Tribunal. US chief prosecutor Telford Taylor stated in his opening statement: "The indictment accuses these men of mature responsibility for visiting upon mankind the most devastating and catastrophic war in human history. It accuses them of wholesale, enslavement, plunder and murder. These are terrible charges."

And he continued, "These accused corporate executives, not the Nazi lunatics are the principal war criminals. If their crimes are not brought to the daylight and they are not punished, they will commit even larger crimes in the future than Hitler could ever have committed."

In 1947, the main charges against the IG Farben managers were:

- Charge 1: the planning and conduction of a war of aggression and the conquest of other countries with the result of unprecedented destruction in the entire world, the death of millions of people and the continued sufferings of millions more.
- Charge 2: deportation, plundering and spoliation of public and private property in the occupied countries with the purpose of permanently exerting economic control in these countries and other severe crimes.
- Charge 3: slavery, mistreatment, terrorizing, torture and murdering of millions of people.

Now, half a century later, the charges in this complaint, are strikingly similar:

- Planning and conducting a war of aggression against Iraq under the pretence of fighting international terror and the proliferation of weapons of mass destruction with the result that vast areas of the country are devastated, thousands of people have died and hundreds of thousands were injured.
- Plundering and spoliation of public and private property in the pursuit of economic power and control in entire regions of the world by escalating an international crisis. Against this war of aggression the accused were deliberately factoring in the use of weapons of mass destruction including nuclear, chemical and biological weapons.
- Genocide by killing, by causing serious bodily harm and by inflicting conditions of life to bring about physical destruction and crimes against humanity of murder and of other inhumane acts.

## **EVIDENCE FOR THE CRIMES COMMITTED**

The evidence for the charges brought in this complaint also relate to two main fields of crimes

- Evidence of genocide and other crimes against humanity committed in connection with the pharmaceutical business with disease.
- Evidence for crimes of war and aggression and other crimes against humanity committed in connection with the war against Iraq and the escalation of the international crisis to a world war.

### **1. Evidence Of Genocide And Other Crimes Against Humanity Committed In Connection With The Pharmaceutical 'Business With Disease'**

Specific evidence is presented that the accused are responsible for deliberately maintaining and expanding diseases, purposefully causing new diseases as well as expanding the use of drugs once registered for one disease to as many other diseases as possible.

To accomplish those goals, the accused have strategically designed, implemented, conducted and organized a business fraud scheme on a global scale that by its economic magnitude is unmatched in human history.

## 1.1. The Deliberate Expansion of Disease

The following specific evidence is presented that today's most common diseases are deliberately maintained and expanded by the accused, despite the fact that these diseases could have been effectively prevented and largely eradicated saving millions of lives.

### 1.1.1. Coronary heart disease

The primary cause of coronary artery disease and heart attacks is a structural weakening and impaired function of the artery wall, which - similar to scurvy - develops as the result of long-term deficiencies of vitamins and other essential nutrients.

In contrast, pharmaceutical approaches to the prevention and treatment of cardiovascular disease deliberately ignore this cause and focus rather on the treatment of symptoms, such as the reduction of cholesterol levels in the blood.

Whilst deliberately avoiding curing the disease for which they are marketed, the detrimental side effects of these pharmaceutical drugs cause new diseases. The worldwide death toll from cardiovascular disease as a result of these deliberate crimes of the accused is in excess of 12 million lives every year.

### 1.1.2. High Blood Pressure

The primary cause of high blood pressure is an increased tension of the artery wall due to a deficiency of essential nutrients in the arterial smooth muscle cells, leading to narrowing of the artery diameter and a rise in blood pressure. A multitude of clinical studies is available documenting the benefits of non-patentable micronutrients, in particular the amino acid arginine and magnesium. They correct the underlying deficiency in millions of vascular wall cells thereby relaxing the blood vessel walls, increasing blood vessel diameter and helping to normalize high blood pressure,

Pharmaceutical drugs sold for the treatment of high blood pressure purposely focus on the treatment of symptoms. For example, beta-blockers reduce the heart rate and diuretics reduce the blood volume. These pharmaceutical drugs deliberately avoid correcting the 'spasms' of the blood vessel walls as the primary cause of high blood pressure. Thus, whilst deliberately avoiding curing the disease, these pharmaceutical drugs have long-term detrimental side effects potentially causing a multitude of new diseases - and thereby new drug markets.

Worldwide several hundred million high blood pressure patients remain uncured as a direct result of these actions by the accused and their death toll is rising daily.

### 1.1.3. Heart Failure

The primary cause of heart failure is lack of cellular biocatalysts, certain vitamins, minerals, carnitine, coenzyme Q10 and other bioenergy carriers in millions of heart muscle cells. This results in impaired heart pumping function and accumulation of water in the body.

In contrast, pharmaceutical approaches for the treatment of heart failure deliberately ignore this fact and focus on symptoms. Diuretics marketed for the treatment of heart failure not only eliminate water accumulated in the body but also wash out vitamins, minerals and other water-soluble bioenergy carriers. Thus, the pharmaceutical drugs marketed for heart failure actually worsen the disease and they are responsible for the short life expectancy of heart failure patients once diuretic medication sets in.

Whilst deliberately avoiding curing the disease, these pharmaceutical drugs flush out essential nutrients from the body, thereby aggravating the underlying cause of the disease. Worldwide over one hundred million heart failure patients remain uncured and eventually die prematurely as a direct result of the actions by the accused.

#### 1.1.4. Irregular heartbeat

The primary cause of irregular heartbeat is lack of micronutrients, vitamins, minerals, ubiquinone and other bioenergy carriers, in millions of electrical heart muscle cells. This results in impaired generation or conduction of the electrical impulses required for normal heartbeat. A recent double blind placebo-controlled study has unequivocally documented that the therapeutic use of micronutrients is an effective safe and affordable way to correct the health condition underlying irregular heart beat.

In contrast, pharmaceutical approaches for the treatment of irregular heartbeat deliberately ignore this fact and focus instead on symptoms. Anti-arrhythmic drugs marketed to treat arrhythmia frequently worsen the irregular heartbeat and cause cardiac arrest and the premature death of patients.

A decade ago the author Thomas Moore documented in his book "Deadly Medicine" that one new class of anti-arrhythmic drugs in the USA alone had caused more deaths than the number of US casualties in the Vietnam War. Worldwide over one hundred million patients with irregular heartbeat remain uncured as a direct result of these actions by the accused and their death toll is rising daily.

#### 1.1.5. Cancer

Until recently cancer has been considered a death verdict. Recent advances in natural health and cellular medicine have fundamentally changed that. For this disease too, it is now obvious that medical research with non-patentable therapies has been deliberately neglected and excluded by the accused in favor of ineffective drugs that allow the continuation of the cancer epidemic as one of their most profitable markets. Because of the extraordinary significance of the crimes committed by the accused in connection with the cancer epidemic it is presented here in more detail.

It is a scientific fact that all cancers spread by the same mechanism, the use of collagen digesting enzymes (collagenases, metalloproteinases). The therapeutic use of the natural amino acid lysine – especially together with other non-patentable micronutrients - can block these enzymes and thereby inhibit the spread of cancer cells. All types of cancer studied thus far respond to this therapeutic approach including breast cancer, prostate cancer, lung cancer, skin cancer, fibroblastoma, synovial cancer and any other forms of cancer.

The only reason why this breakthrough in medicine has not been investigated further and applied in the treatment of cancer patients worldwide is the fact that these substances are not patentable and therefore has low profit margins. More importantly, any effective treatment of any disease ultimately leads to its eradication and to the destruction of a multi-trillion-dollar market of pharmaceutical drugs.

The pharmaceutical drug marketing for cancer patients has been particularly fraudulent and malicious. Under the pretence of treating cancer using the cover-term 'chemo-therapy' toxic substances, including derivatives of mustard gas, are applied to patients. The fact that these toxic agents also destroy millions of healthy cells in the body is deliberately factored in.

Knowing this fact, the following consequences were deliberately taken into account: First, cancer would continue as a global epidemic, providing the economic basis for a multi-trillion-dollar continued business with this disease. Secondly, the systematic application of toxic agents in the form of chemotherapy causes an epidemic of new diseases in cancer patients receiving these toxic substances.

As a result of this strategy, the pharmaceutical drug market from treating the dangerous side effects of these drugs – including infections, inflammation, bleeding, organ failure etc. – is even bigger than the market of the chemotherapy drugs

itself. Thus, the accused also applied their organized deception scheme also to the detriment of hundreds of millions of cancer patients with one purpose only: their financial enrichment.

#### 1.1.6. AIDS and other Infectious Diseases

Similar deliberate deception schemes were applied for the treatment of one of the most deadly epidemics in human history, AIDS. Already 10 years ago scientific studies have shown that vitamin C is able to reduce the replication of the HIV-Virus by more than 99%. This fact has been known to the accused for more than a decade.

Deliberately ignoring and bypassing this safe and affordable non-patentable treatment, the accused developed patentable drugs against AIDS, with severe side-effects and - due to their exorbitant patent royalties - unaffordable to the great majority of the people on this planet. Thus, by applying their criminal business scheme, the accused are guilty of risking the lives and causing the deaths of hundreds of millions of people in Africa, South America, Asia and all the other regions of the world.

In a similar way, they have boycotted the information that the single most important measure to enhance immunity against infectious diseases is an optimum intake of vitamins B6, B12, Folic Acid and certain other essential nutrients. It is a scientific fact that these biocatalysts of cellular metabolism increase the production of leucocytes, the body's main weapon against any infection. By systematically withholding this information, particularly from hundreds of millions of children and adults in the developing world, the pharmaceutical industry deliberately risks the lives of hundreds of millions of people in these areas of the world. All the accused know that hardly anyone in these areas of the world can afford pharmaceutical treatments and they will consequently die.

Withholding this lifesaving information about natural, non-patentable alternatives to prevent and fight infectious diseases, not only leads to the death of millions of people, but also to the ruin of the economies of many developing countries. As a direct result the already existing imbalance in the current world economy is dramatically aggravated. These countries are deliberately placed in a conflict where they can only lose.

#### 1.1.7. Other diseases

In a similar way, other degenerative, inflammatory, infectious diseases and many other of today's most common diseases only continue to exist as health problems because the accused have defined them and protect them as the markets for their criminal 'business with disease.'

## **1.2. Evidence about the criminal marketing schemes of the accused**

### 1.2.1 Deliberately Expanding Diseases and Causing New Diseases in Patients to Expand Pharmaceutical Drug Markets

To expand their markets the following groups of drugs are manufactured and marketed by the accused deliberately, in spite of their known detrimental side effects. In a criminal manner, the accused are deliberately causing new diseases under the pretense of fighting existing ones. The fact that these new diseases caused by the side effects of these drugs surface many years later is used as an additional cover for this deceptive scheme:

Cholesterol-lowering drugs, particularly statins and fibrates are mass-marketed under the pretense of preventing cardiovascular disease. These drugs are known to induce cancer at doses currently administered to millions of patients worldwide.

Chemotherapy drugs are marketed to allegedly treat cancer. In fact, they cause a series of severe side effects the most frequent of which is setting off new cancers. The entire criminal marketing scheme around chemotherapy can only work because the accused have rendered cancer a death verdict – and even a few month's survival of a patient on chemotherapy is being marketed by the accused as a success story.

Aspirin is mass-marketed under the false pretense of preventing heart attacks and strokes, whilst long-term use of this drug is known to cause an destroy collagen and therefore gradually increase the risk of heart attacks and strokes as well as other diseases such as stomach ulcers and gastrointestinal bleeding.

Anti-inflammatory drugs are used to treat pain and inflammation, e.g. in arthritis. However, many of these drugs destroy connective tissue, e.g. the joints. With their long-term use these drugs aggravate the health problems rather than healing them.

Calcium antagonists are mass-marketed under the false pretense of treating high blood pressure and preventing heart attacks, whilst long-term use of these drugs is known to cause an increase in heart attacks, strokes and other diseases.

Estrogen and other hormone drugs are mass-marketed under the false pretense of preventing osteoporosis and heart disease, whilst long-term use of these drugs is known to cause cancer in more than 30% of the women taking them. Particularly frequent forms of cancer caused by these drugs are hormone dependent cancers such as cancer of the breast and uterus.

Tranquilizers and anti-depressants. Another mechanism by which the accused systematically expand their markets is to deliberately cause addiction in order to increase drug sales. Many tranquillizers and anti-depressants, including widespread diazepam ('Valium') are known to cause dependency and addiction. In order to expand their global sales of these addictive drugs, the accused even praise them through full-page adverts directly to the public.

Other drugs. Since patentability is a precondition for the pharmaceutical investment business typical pharmaceutical drugs are synthetic molecules and therefore toxic to the human body. For almost all drugs the same fraudulent business principle is valid – alleviate symptoms short term whilst, at the same time causing damage and gradually generating new diseases as the basis for new drug markets.

### **1.3. Expanding their drug markets to new diseases**

In executing their crimes, the accused deliberately extend their existing pharmaceutical drug market by inventing new health conditions for which they recommend the drugs that had previously been recommended for other diseases. As first evidence the following examples are presented here:

Headache pills allegedly prevent heart disease. Aspirin was developed as a headache and pain relief pill and is now being mass-marketed and recommended by the accused for long-term use, even by healthy individuals for the alleged prevention and treatment of heart disease and other severe health conditions.

Antibiotics allegedly fight coronary heart disease. In order to extend the global market for their antibiotic drugs, the accused fabricated and spread the so-called "bacteria-theory" of heart attacks on a worldwide scale. Without any clinical evidence that chlamydia or other bacteria actually cause atherosclerosis or heart attacks the accused criminally promoted the general use of antibiotics even for healthy individuals with the false pretense of preventing heart attacks.

These are just a few examples of the practices by the accused to systematically expand the use of their drugs to other diseases. In fact this marketing scheme is not the exception, but the rule. The list of crimes committed in this context should be amended and completed during further investigation.

### **1.4. Crimes Connected With The Systematic Infiltration Of Various Sectors Of Society With The Purpose To Facilitate Committing These Crimes**

The accused have systematically and deliberately infiltrated medicine and the health sectors of most countries in the world to create financial and other dependencies in order to conduct their 'business with disease' and commit other crimes.

Medical research is not performed with the primary object to find the most effective, safest and most affordable treatment against a disease, but with the goal to identify the largest disease markets and to achieve the highest gains in that market for the drug manufacturer. As part of this strategy over recent decades, the accused systematically removed from the training programs at medical schools the knowledge about effective, but non-patentable natural therapies. They purposely producing generations of doctors with little or no knowledge about the life-saving health benefits of these natural therapies. Simultaneously, therapeutic education at medical schools was taken over by the newly created departments named pharmacology. Thus, over decades generations of doctors have been leaving medical schools practically as a trained sales force for the pharmaceutical 'business with disease'. In order to hide this strategy, patented drugs were portrayed as 'scientific' and even baptized 'ethical drugs' whereas non-patentable natural therapies were discredited as 'unscientific.'

In a similar way the accused have systematically and deliberately infiltrated the mass media around the world, creating financial and other dependencies, disseminate deceptive and false information in order to conceal their criminal practices, promote their 'business with disease' and commit other crimes.

The accused have deliberately and systematically abused the legislative and political system of most nations to pass laws, establish regulations and promote other measures with the purpose to expand their sales of ineffective, unsafe but lucrative pharmaceutical drugs. The accused abused their political influence to coerce legislation that would allow them to appropriate trillions of dollars under the cover of 'health insurance' and other public and private health funds. By promoting their fraudulent 'business with disease' they have taken this money from individuals, corporations and governments around the world by requesting payment for ineffective and harmful therapies. Thereby, the accused secure exorbitant gains for the pharmaceutical industry and causing unnecessary suffering and premature death of hundreds of millions of people.

The accused have purposely and systematically infiltrated and abused the European Parliament and other regional and international bodies including the United Nations Organizations, the World Health Organization (WHO), the Food and Agricultural Organization (FAO) and other national and international political bodies to commit their crimes against humanity.

### **1.5. Crimes Connected With The Systematic Obstruction Of Effective, Non-Patentable Health Measures**

To protect their artificial investment business with disease, the accused tried to strategically eliminate access of the people of the world to non-patentable natural therapies. To accomplish this goal the accused used several strategic measures:

1. Withholding life saving information about non-patentable natural therapies. The accused have deliberately and systematically withheld and blocked the basic health information from millions of people that the human body does not produce its own vitamin C (ascorbic acid). Because of the lack of this knowledge almost all humans suffer from vitamin C deficiency and are susceptible to cardiovascular and other diseases. In a similar way, the accused have systematically and purposefully withheld and blocked the basic health information from millions of people that the human body does not produce the natural amino acid lysine. Because of the lack of this knowledge almost all humans suffer from lysine deficiency and are susceptible to cancer and other diseases. Thereby, the accused deliberately cause further unnecessary suffering and the premature death of hundreds of millions of people.
2. Publicly discrediting non-patentable natural therapies. The accused have willfully and systematically deceived the public by disseminating false, misleading and fabricated information discrediting non-patentable health therapies with the goal to protect and expand their 'business with disease' based on patented drugs and to commit other crimes. Thereby, the accused deliberately cause further unnecessary suffering and the premature death of hundreds of millions of people.

3. Outlawing the dissemination of health information related to non-patentable natural therapies. The accused have deliberately abused their political influence trying to implement legislation at the national as well as the international level that would essentially outlaw the dissemination of preventive and therapeutic health information related to non-patentable natural therapies. At the same time, this legislation seeks to establish arbitrarily low 'upper limits' for the amounts of these natural and safe therapies, a step intended to prohibit their use as natural therapeutic agents. By abusing the United Nation's 'Codex Alimentarius Commission', the accused have even been trying to establish such laws for all member countries of the UN – that is worldwide.

1.5.5. Now that all peaceful efforts to protect the pharmaceutical 'business with disease' have failed, the accused refrain to another strategy. They are deliberately escalating an international crisis, including wars, in order to create the psychological and legal precondition that would allow an immediate and global implementation of protectionist laws and cement the continuation of their 'business with disease' and the other crimes of which they are accused.

## **2. Evidence Of Genocide, Crimes Of War And Other Crimes Against Humanity Committed In Connection With The War Of Aggression Against Iraq**

The accused are committing the crime of deliberately escalating an international crisis including wars of aggression towards a war that includes weapons of mass destruction.

The accused have been consistently abusing the tragedy of September 11th for the purpose of building up an international crisis scenario, which they ultimately used as a justification for their war of aggression.

Whilst the accused maximized the psychological factor of this tragedy they have blocked an official investigation into the actual events and the background of September 11th. It was The White House itself that blocked the institution of an independent commission for over a year.

Thus whilst the facts about this tragedy are not fully disclosed to the public the events of September 11th have been abused as the justification for the international crisis situation ever since.

Whilst failing to disclose any convincing evidence about September 11th they abused this tragedy to conquer the country of Afghanistan. The military conquest of Afghanistan was followed by the plundering of its natural resources, by the accused, for their financial gain.

In a similar way the accused used this pretense to conquer the next country, Iraq. Under cover of fighting the proliferation of weapons of mass destruction, the accused were trying to coerce the world community into a war of aggression against Iraq.

Despite the fact that the great majority of the UN Security Council, the vast majority of the member states of the UN and overwhelming world opinion opposed this war, the accused still launched their attack.

**The war planned, started and conducted by the accused was a war without any international mandate and therefore constituted a war of aggression and a crime against humanity. If the accused are not brought to justice for this crime, the entire system of international law as designed after the Second World War to protect mankind from destruction, will collapse.**

In the absence of any international mandate the only justification left for the accused to commit this criminal act, was to fabricate a pretense - their alleged search for weapons of mass destruction in Iraq. Today the entire world knows that this too was a deception.

During their war of aggression against Iraq, tens of thousands of Iraq people – soldiers and civilians alike – were killed. Killing of that magnitude during a war without any international mandate constitutes the crime of genocide.

In addition, hundreds of thousands of innocent people – many of them children – were injured, mutilated, or suffered physical or mental harm caused by the criminal acts of the accused.

Moreover, the accused purposefully and systematically seized the oil fields and other natural resources of Iraq with the purpose to exploit them to enrich themselves. To cover up their crimes the accused disseminate the false justification that their seizure of the oil resources would be in the interests of and to the benefit of the Iraqi people.

With the occupation of Iraq and the appropriation of its resources in a war of aggression, the accused also committed the crime of plundering and seizing the enemy's property.

The accused systematically promoted this crisis escalation to further curtail civil rights through so-called 'anti-terror' laws. To deceive the people while committing their crimes these laws were deliberately given deceptive names, e.g. 'Homeland Security Act', or 'Patriot-Act', thereby coercing political support for the abandonment of civil rights.

Whilst systematically organizing this escalation the accused also deliberately abused the media distraction and made their first moves trying to implement protectionist laws on behalf of the pharmaceutical cartel. Largely unbeknown to the US Congress at that time, a provision was inserted into the Homeland Security Act granting immunity to drug makers from product liability law suits.

This is but a short synopsis of the crimes of war and crimes against humanity committed by the accused and of their strategy to abuse these war crimes to continue crimes of even larger magnitude, such as cementing their global 'business with disease'.

In the course of the further investigation of these war crimes, all available resources must be used to bring the accused to justice. This includes particularly all information available through the United Nations organizations, the UN weapons inspectors, documentation of war crimes from Iraqi and international sources and all other available sources.

The people of the world will demand to be part of this process and contribute documentation about these war crimes in order to accelerate the process of justice.







## The Jurisdiction Of The International Criminal Court Over The Accused

The accused committed the crimes outlined above, knowingly and deliberately and in full knowledge of all the circumstances surrounding their actions.

The crimes reported here have been committed against all mankind. The ICC in The Hague is the court governed by international law addressing these urgent issues.

Moreover, the ICC was established after WWII and the Nuremberg Tribunal, with the goal to prevent another tragedy from happening – possibly a world war.

### 1. Liability to prosecution of those bearing office

The accused can be both sentenced and punished by the International Criminal Court.

The Statute applies equally to all persons without any distinction based on official capacity. In particular, official capacity as a Head of State or Government, a member of a Government or parliament, an elected representative or a government official shall in no case exempt a person from criminal responsibility under the Statute of the ICC, nor shall it, in and of itself, constitute a ground for reduction of sentence (Article 27, Paragraph 1 of the Statute).

Immunities or special procedural rules which may attach to the official capacity of a person, whether under national or international law, shall also not bar the Court from exercising its jurisdiction over such a person (Article 27, Paragraph 2 of the Statute).

### 2. Exclusion of criminal responsibility

None of the accused may invoke any of the grounds specified under Article 31 of the Statute for excluding criminal responsibility.

The accused were acting in full knowledge about the illegitimacy of their actions. Thus, any claims to the contrary are null and void.

Equally null and void are all efforts by the accused to retroactively justify their crimes by forming 'coalitions' of opinions with other nations.

### 3. Power to inflict punishment over members of the US Government and citizens of the USA

Even those of the accused, who hold citizenship of the United States of America, cannot claim immunity from criminal prosecution before the International Criminal Court, just because the United States of America in contrast to 90 other countries around the world (i.e. almost half of the members of the United Nations) is not amongst the signatory states to the Rome Statute.

The accused have long been devising plans to try and evade the power to inflict punishment of the International Criminal Court. This, however, does not exempt the accused from the jurisdiction of the International Criminal Court, because the mere performance of the crimes involved in the acts to be judged before the ICC constitutes liability to punishment under the terms of the Statute.

It does not matter if you belong to a specific Member State, because the International Criminal Court has jurisdiction over natural persons and not over

States and establishes individual responsibility and liability for punishment (Article 25 Paragraphs 1 and 2 of the Statute).

The ICC Statutes render attempts by the US Administration to coerce smaller nations into bilateral 'immunity pacts' redundant.

In addition, the UN Security Council did rule that the US Government and therefore also the majority of the accused could not and should not decide themselves whether the International Criminal Court could take action against them or not.

This decision was taken for good reason: One can only imagine what would have happened if the main figures accused in the Nuremberg Trials had been allowed to choose whether they had to stand trial before the Nuremberg Tribunal.

For these reasons the accused, even if they are citizens of the United States of America, are still subject to the power to inflict punishment of the International Criminal Court.

## Final Appeal

The individuals named should be indicted before the International Criminal Court on the basis of the valid grounds specified in this complaint.

The investigations into the individual responsibilities of the accused are to be taken up and continued by the Prosecutor of the International Criminal Court.

These investigations will also be continued and intensified on our side, the side of the people of the world.

The accused should be convicted for the following reasons:

- \* knowing and deliberate violation of the human right to peace;
- \* knowing and deliberate violation of the human right to life;
- \* knowing and deliberate violation of the human right to health.

This complaint is to be updated and completed in a system of constant development and revision until legal proceedings finally commence against the accused.

This complaint deals with the largest crimes ever committed in the course of human history. Every day that formal proceeding at the International Criminal Court against the accused are delayed, millions of people worldwide will pay with their lives and the world moves closer to the next world war. There must be no delay.

As the US Prosecutor in the Nuremberg War Tribunal against the executives of the chemical/petrochemical cartel IG Farben stated: " If the crimes committed by the accused are not brought to the daylight and if they are not held accountable, they will do even more harm in the future."

We call on every person and every Government in the world to unite behind the charges. The time to act is now.
